GRIZZY BEAR LEGAL ACTION-DAVID BEARSHIELD

David Bearshield-I am the Chairman of the GOAL Coalition. There was a letter of agreement faxed to the Tribal Council. The grizzly bear will be removed from the endangered species list and will be trophy hunted at the end of this month. No money will be given and the Northern Cheyenne Tribe will not be charged in this case. The proposal for delisting will take place at the end of the month.

Tracy Robinson-Have you been in contact with Brian Chestnut?

President Fisher-I support what you're doing.

Conrad Fisher-Have we talked to Brian about this particular resolution?

Tracy Robinson-I'm calling right now.

Conrad Fisher-There are cultural resource laws. This avenue has been going on for some time. We submitted a resolution opposing the delisting. We told them to come over and meet government to government. They were give that resolution opposing the delisting. I want to make sure we're all on the same track. We will talk to our attorney about this. We're really cautious about making sure we're all on the same page.

David Bearshield-If you would pass this today, an amendment could be in there. We want to make sure the Northern Cheyenne are on board with us.

Joe Fox, Jr.-I think it's great what you're doing. To be on the safe side, we need to look at the legal aspects. I think it would be good to wait for Brian's legal advice.

President Fisher-We met with our attorney and we don't know about the third party language.

Tracy Robinson-Our attorney is off site. He'll be here next week. He did not write the resolution but he did make comments.

David Bearshield-I talked to Mr. Chestnut. Mr. Fisher has the agenda item removed. Because of consultation in Bozeman, this resolution was released from your attorney to our attorney. I'm highly concerned that there's not remembrance on that. I want to make sure there's confirmation. We want to make see that clear communication is met. I do not want to leave the Northern Cheyenne out. My concern is, if we procrastinate, we'll be in the back. We've had an open forum for 4 months.

Tracy Robinson-The resolution we passed, we said we oppose the delisting of the grizzly. We still stand behind that. Just because we don't pass this resolution today, doesn't mean we don't support it.

David Bearshield-We could use this as a standing resolution. This supports strongly behind that.

Conrad Fisher-I hear what you're saying. Once again, there seems to be confusion and contradiction on the author of this resolution. Our attorney will be here next week. The extent of our support, whether or not this is the particular document. We need to get a handle on it. At this point, we don't know what's going on.

David Bearshield-There is a third party, the Reynolds group is paying for it.

Conrad Fisher-Our attorney is coming on the 23rd, we'll know exactly what we're going to do with this.
