Conrad Fisher-Sheldon was on top of that, he had concerns about the lack of cooperation by Headstart. The bigger concern is exactly that. The Executive Administrator gave him a deadline. He should be here to give us updates.

President Killsback-We do have orientation set up for the 28th.

Ernest Littlemouth-In the meantime, let's look for a new director.

President Killsback-Let me get through orientation. Let me review the program and see if it needs restructuring.

Ernest Littlemouth-It's been going on for I0 years now.

BIA SUPERINTENDENT UPDATE-MIKE ADDY

Mike Addy-I'm hoping to get an update on the lands act today. I'll send an e-mail if I get anything.

Vice President Fisher-Are you saying that it may not have been submitted in a timely manner?

Mike Addy-If they didn't get it today, then it's late.

Vice President Fisher-Here, we did it in a timely manner. It will be really disappointing to know that it didn't make it there on time.

Mike Addy-When I submitted it, I did let them know that it's critical and needed signing right away. The President wants to schedule an orientation early in the New Year.

President Killsback-I said the first week in January. We have Wed. & Thurs. open, and we'll be rescheduling some of the ones we missed.

Benji Headswift-It will probably have to be Thursday. We need to have Land authority and Grazing.

Mike Addy-We have positions open, we're trying to get them advertised and filled. There's word that Trump might do a hiring freeze. Self Determination, we made a selection on that, we're waiting for background. We did make a selection for a Deputy Superintendent, we did make a selection but the candidate declined.

President Killsback-What's up with GA?

Mike Addy-We got funded. We're expecting another allocation by the first of the year.

Benji Headswift-Are you expecting another shortfall?

Mike Addy-Yes, we only got funded 80%, we're hoping to get ahead of it and keep funding at least for the Fiscal Year. We're funding probation. We need to meet with the judge.

President Killsback-I need to follow up on a couple of verbal complaints on your Social Service Director. I can talk about the lack of cultural sensitivity, the director has. I would like to meet her to put a face to the voice.

Debra Charette-I would like to compare it in black and white.

President Killsback-I have it here. You're making an informed decision here. We're omitting it, now adding language.

Benji Headswift-I don't understand why you are having a working session on the Council floor instead of with the program.

Melissa Lonebear-In the current Personnel Policies, it does include the President, Vice President, Secretary, Treasurer, and Clerk of Court.

President Killsback-As appointed officials, not elected. We are not subject to the personnel policies. You are not managed under those provisions. I ask that the council to at least identify who will sign these documents. Other than nobody being identified. Those are key, to account for their time, approve their leave, when they take leave, or who's going to sign they're trip reports.

Ernest Littlemouth-I think we need someone to be here that's going to be here all the time.

Joe Fox, Jr.-The Tribal Council gatekeeper is the Sgt. at Arms, and I would get the Budget & Finance Chair. The authority of the Secretary and Treasurer, they work at the pleasure of the Council.

President Killsback-Again, that burden falls back on Benji, for keeping time. That concern from Councilman Littlemouth, for being on time. Punctuality is key, the only way we are able to provide leadership. The Council here is 24-7. There is a work day, I ask that Tribal Council try

to meet those hours. I ask that Tribal Council to also meet those hours. I'm asking that we narrow down who is responsible for time sheets, leave slips, etc.

The reason they revised the Culture Commission Ordinance, is the workload is really heavy. At that time, they didn't have very much, they were being treated like the elderly commission. The 106 process is a mitigation process.

President Killsback-I went with letters and I talked to these guys, two of them are from the old commission. They were my supporters and wanted to maintain that role. After I looked at the budgets on that organizational chart, I think these guys would be capable enough.

Benji Headswift-Based on those comments, I believe this is a good commission. With Wallace and Vincent.

Dana Eaglefeathers-This is a well put together list. I wanted to afford the opportunity to Rufus to state the guidelines.

President Killsback-I'm going to reach out to you for guidance when we evaluate and review the THPO office.
