#### HEADSTART UPDATE-NOT PRESENT

#### IHS UPDATE-DEBBY BENDS

Debby-We got from the Acting IHS Director, there's an attack on hospitals. They get ahold of your system and request payment for getting your system back. As of today, we have not gotten reports that this has happened to our system. They are requesting strong passwords. They are keeping IHS informed. PRC is continuing to do well. In terms of PRC, we are projecting surplus. We are at a level 4. The greatest benefit is the Medicaid expansion. We're hoping that will continue. Budget wise, we continue to operate in the black. We are down four providers, pediatrician/chief medical officer, we have family practice physician, and Pauline King, at an intermittent level. We are interviewing for a Med Tech position. Physical therapist, and engineering. We interviewed a young Native American female. In terms of quality initiatives, CPC Class, it's a partnership with the State of Montana. We are working with St. Vincent's for tele-health. We just got credentialed for prenatal care from St. Vincent's. We are trying to create a model to get our addicted mothers to get clean, to deliver their baby. Neonatal abstinence syndrome. The biggest issue is trying to get accurate data. I was wondering if you would like to schedule an occasional working session?

President Killsback-I'm open to that. I would like to reestablish the relationship we had.

Debby Bends-Eugene and I are trying to get together weekly.

President Killsback-Get with Brandon and we can get with the Council. We have a tribal position that's mirroring that position to work with meth addicted mothers.

Debby Bends-It's critical that we try to turn this around, so the mothers are healthy to raise their children in a good way.

President Killsback-We met with the drug force group last week. One of the concerns was the prescription drug abuse. And the hand to hand transactions happening at our service unit.

Debby Bends-We're open to working closely with the Tribe as well as drug enforcement agencies.

Vice President Fisher-We need to keep that dialogue going. It's an epidemic that's nationwide.

#### NCDC-SOLID WASTE MANAGEMENT-BEN LONEBEAR

Ben Lonebear-I have three resolutions. This authorizes the takeover of operations of the solid waste management. Under Section 17, asking the Treasurer to transfer assets within the next 30 days. We are asking for the solid waste program to partner it with a propane company. It bills our tribal members and it's a revenue generating company. The second one is for cell tower revenues of \$200,000. We're asking that future revenues, be turned over in total for this year. This is providing myself with salary half time. The depot is making substantial profit.

Sheldon King-All of the 2017 meeting will go to NCDC?

Ben Lonebear-Yes, at the annual meeting, the charter asks us to pay our own bills. It also asks us to compile reports. Also, to provide some kind of dividend to the tribe. At that time, we'll be discussion 2017 revenues, and pushing some of those back to the Tribe. We have full accounting going on right now.

Joe Fox, Jr.-The Tribe's initial goal is to be successful in doing business. So we can accommodate our tribal membership. In that perspective, when this charter took over, we look at it at an arm's length. Eventually the Tribe will benefit in the long run, so down the road we'll see the prosperity.

Waylon Rogers-A few of us wanted to have a working session on this. Dana, and myself, and Merlin wanted to sit down and talk because we do have some needs, that the tribal membership needs. I wanted to ask that we have a working session before we hand the money over to you.

Merlin Sioux-Right now, we are not looking out for the shortfall of LIHEAP.

President Killsback-You're asking for the revenue. You do have ½ to work within budget for the shortfalls. Program matches, and we have unallowable costs that need to be addressed.

Ben Lonebear-Our annual meeting will be to discuss our interests. To request for ½ to fit the needs. Dana was there briefly, he was in agreement as well.

Allen Clubfoot-As far as the coalition and the committee, the coalition as a whole, everybody is involved to help save our language. If we don't do anything, we're not going to have a language by 2040, that's a prediction. I'll have Diane introduce our officers. Right now, we're doing language with THPO, there's only three of them that showed up. What Ben was saying, that should expand.

Diane Spottedelk-The coalition meets every other Thursday, I'm more of a student there. I'm not a speaker but I understand. Most of the coalition members do carry Class VII, they should be utilized somehow. Those that do have it, should be used.

President Killsback-Amending the section for the leave, maybe in the resolution to allow administration to articulate that. I was asked at an interview, do you think it's appropriate for tribes to fund language. I said yes. We'll just take the language and amend our personnel policies.

Ben Lonebear-A lot will be internal process management. We'll have to figure out time management.

Sheldon King-Is it possible for the coalition to go to each district? Some of our elders, don't like to leave their house.

Allen Clubfoot-We talked about that.

Ben Lonebear-Is 90 days realistic?

President Killsback-Yes, we can get that.

Ben Lonebear-The ultimate goal is to bring language for the forefront for every day interactions. The first year will be tough.
