#### ANNOUNCEMENTS

Benji Headswift-We did go down to Las Vegas, we did some sight-seeing of facilities. One in particular was Moapa Tribe solar facility. The progress they made in the last seven years, was pretty amazing. They looked into partnering with solar City. They got their first partnership, with the largest solar facility in the nation. I brought 168 jobs to their tribe for 4 years. They're looking at finalizing their first power purchase agreement with Los Angeles. The other power purchase agreement their working on is with Mandalay Bay. That put it's at a mass scale for solar endeavors. We have to figure out whether we're going to do it at a consumer or corporate level. We dreamed of going into PPL wires. Another note, we visited the Las Vegas Paiute Cannabis. They have the same structure as us. They're three blocks from Freemont Street. They've been in recreational and medical marijuana, they've had huge success. They did express to us, Chairman Tso would be more than happy to work with us. It's just an idea at this point. There are pros and cons. We have a vast amount of medical card holders that have to drive 180 miles to get their medicine. They have 30 employees. One thing they have, is they are a major city. A lot of good things come with it. If we would go to the HIS hear and the opiates, nobody is going to complain about that. The way they're selling it, you can actually purchase it without THC. NUWUcannabis.com. You can take a look at their product. It was amazing to look at the community, and their pride. One down fall, is the financial institute that's going to hold that kind of money. I'm really excited about it. One of the things they talked about was transparency from the get go. As of right now,

they have a good relationship with the federal government. The majority of the people that were there were elderly people.

Acting President Fisher-I think those are good viable opportunities, the second is very creative.

Sheldon King-Last week, thank you for letting me go and testify. We didn't speak on behalf of Sierra Club, we spoke for the coal miners for some of the training. It's going to affect our community, affect our membership. We used our own travel, we're speaking on behalf of our own tribe. He said "Mr. King, you have two minutes", so I used 10 minutes. On behalf of our tribe we should all be there.

Acting President Fisher-Did you say your Indian name?

Sheldon King-How many times have you been here, and how many times have you seen our Headstart Director?

Acting President Fisher-Not very often.

Sheldon King-We were on a five year plan, it's hurting our young kids because they're not ready for Kindergarten.

#### NCTHA ORDINANCE AMENDMENT-WILLIE ROWLAND

Just recently the Council passed the amendment that no one have a delinquency on the board. We cleaned up all the language. The Council has the authority to change this anytime they want. We are asking the Council today, to rescind, and helps us to revive the staggered terms.

Acting President Fisher-There's 13 pages here, I would like to ask the changes.

Lafe Haugen-The Council passed, that when someone is removed, you can't be reinstated. This one says, when you're removed for cause. (page 13, number 10). We thought it was unfair because it was disqualified for someone like Troy. When the Council wants to appoint someone, I won't say yay or nay, I'll just tell you if they're delinquent. It really put us in limbo, because we weren't

sure of the intent of the language. What it does is really implements the staggered terms. This board will have to report to the Council every six months. It holds everyone more accountable.
