Stephanie Connoly-I want to thank you for your comments, and we're looking for formal consultation. I need a name for a contact person.

President Killsback-We can have the Vice President to serve as point of contact.

Vice President Fisher-Too many times, we see a non-indian archeologist and going out and identifying sites. It should be the tribes that should be out there working side by side. We have just as much cultural knowledge as an archeologist that has a PHD. These are the traditional sites of our Cheyenne people.

Teanna Whitedirt-There was a meeting in Spearfish in December. We all agreed that Tribes will be involved in this project. That's what we emphasized at the last meeting we have.

Vice President Fisher-You have the leadership here, you have the tribal council here. That's what the leadership is saying. You have your leaders, we have our leaders.
