Merlin Sioux-Block party on the 15th. We're trying to do the summer bash.

Ernest Littlemouth-I know I haven't been to a budget & finance meeting. We need to put money in for summer feeding.

Debbie Charette-You didn't put a proposal in. You didn't put in a request.

Sheldon King-We do have a meeting with Northern Cheyenne Tribal Schools on Thursday morning. We need an update from NCTS for tribal members that aren't being hired back. If you have a principal and Superintendent that can mentor. Since I've moved back, he was there when I first left. It's our tribal members that need security. I want to hear it from them, and give them the opportunity to speak.

President Killsback-I came from a Tribal Leaders conference in Billings. There's a lot of issues going on. They're looking at doing a charter, to follow the Great Plains leaders.

Sheldon King-Coming from the Busby District. We did start our garden. There is a district meeting tomorrow.

Debbie Charette-Our district put our garden on hold.

Waylon Rogers-We're still waiting for funding for our garden.

#### **IHS UPDATE-DEBBIE BENDS**

Debbie Bends-I want to express my condolences, to Dana and anyone else that was affected by that accident. I wanted to say how heartbreaking that is for our community. Our prayers go out to anyone that lost someone in that tragic event. We are one people and share that same pain and same grief.

Willie Rowland-Did you provide counseling for any of the EMS workers.

Debbie Bends-We did that Monday, I'm not sure who attended. That's very important. We need to take care of our mental and spiritual health.

Debbie Bends-Last week I brought Dr. Palmertree. He is focusing on getting training for the dental staff. Dr. Palmertree is working on brining services in house. We'll be able to do more in house oral surgery. Crow will be very soon doing CT Scan services.

Sheldon King-With the transportation, if someone that had a simple appointment are they allowed to go to Billings?

Debbie Bends-They have to have a referral and if there is seating available. We try to schedule them when seating is available. We are at a level four, almost everything is going out that needs to be seen. We are within our budget, we're still in the black. Transportation is part of the PRC program. We did just send a transportation driver to Salt Lake. We transported 300 patients in the month of May. We are expanding on the telemedicine program. We are expanding speech therapy. We think this method is going to explode. One of the areas you need to be aware of, I had reported some time ago about Big Horn County backing out of servicing. It was mainly due to funding. We are really feeling it now and last week we had four flights.

Merlin Sioux-How much are flights?

Debbie Bends-Anywhere from 10-17 thousand.

Merlin Sioux-Utilities will be doing sludge removal. Giving you a heads up.

President Killsback-We received a letter from area regarding the Crow/Northern Cheyenne Hospital. Have we had any participation in the governing board?

Debbie Bends-I don't think so, not to my knowledge.

Sheldon King-Exits for MIGA meeting at 10:20 a.m. Debbie Charette is taking over now.

Debbie Bends-There are a few programs that were terminated and we have to pay.

#### **ENROLLMENT-DEBRA CHARETTE**

Vice President Fisher-I know you've been working on updating the enrollment ordinance. Where are you with that?

President Killsback-The enrollment committee could have community input. That's a lot of work and maybe put some resources to it. Fourth of July may be the perfect opportunity.

William Walksalong-Board of Health and Housing has hired Scott Small as a drug enforcement officer.

President Killsback-I still had concerns. The concern I addressed, we have a Public Safety Committee, I want some kind of involvement in this committee somehow. We have to wait and see what the Bureau says.

William Walksalong-Drugs are killing our people.

Leonard Elkshoulder-I'm the chairman of the Public Safety Committee. The Chief of Police brought up this MOA. OJS tentatively disagreed with this MOA. The thing is, Law Enforcement is a restricted area. The Council rescinded that resolution which authorizes us to continue with the agreement to contact law enforcement. We gave his some of the things that Public Safety Committee came up with. We've been meeting with the districts. They want people from here. The people that are detailed here, don't know the people or the area. We also got in contact with the Montana Attorney General. He was in agreement of helping us. We all know that Housing Authority shouldn't have anything to do with Law Enforcement. I'm not opposed to the MOA, we feel that the Tribe and Public Safety Committee should be involved.

Glenn Littlebird, Sr.-Unless someone comes in here from another reservation, they have to have the mindset that they're going to accept the people that they work for. I see our people seeing mistreated for minor things. You never know, you might make a mistake and might have to deal with our local law enforcement. Leonard touched on a lot of things that we were talking about. I believe we can police our people in a more mature and cultural way. I'm in agreement with that drug enforcement officer. I see it every day. Certain people, you can see the traffic every single day. They're supposed to 24-7 patrol services. The police aren't even friendly. I've been in law enforcement 24 years and I never treated people like that.

Vice President Fisher-In reference to the gentlemen that spoke. There is some concern. Is Housing subsidizing this with funding?

Debbie Charette-Yes, since most of the activity with drugs in their housing.

President Killsback-It'll pass and go up the chain.

Debbie Charette-It's already there for review, we're just here to push.
