President Killsback-We can get into that discussion, I was the health director when we sued IHS. Wellness is about prevention. Would you rather help 30 people or 300 people? If housing is going to be an oversight, I agree with Bear Construction, I've seen their work at Busby School. I don't want housing to lose sight of their goal either.

Sheldon King-We were told if we included dialysis on the building, Shakopee would pay for their dialysis machines. There's a lot of need that goes on, we need to address it. I think we need to go through everybody. It's not only a gym, it's a place where Lame Deer can have someplace to have things.

Lisa Just-In regards to a dialysis center, we do have plans down the road.

Vice President Fisher-The concern I have is sole sourcing. How does the board feel about it?

Sharlene Evans-We have been discussing that, we felt we were left out of the planning. It seemed like, no matter how we wanted it built.

Lisa Just-Abdul has done work on the jail as well as the youth detention center.

President Killsback-If you go to Busby School, they re-did the bathrooms. Check them out.

Sharlene Evans-We want to have a good building down the road, we want something that's going to last us.

President Killsback-I'm hoping we don't build something just to build something. Input is important.

Sharlene Evans-We need legal counsel for Tribal Health. I want an explanation why this wasn't put on the agenda.

Sheldon King-The reason it wasn't put on the agenda. You come from Board of Health, and you make these decisions, we hired a tribal lawyer. Have you ever talked to our tribal lawyer, we're not going to disregard because he's a tribal member. We're trying to use our dollars for what we can. Yes, we have a tribal lawyer. He's there at the discretion of our programs. He makes special visits.

Sharlene Evans-There was no explanation to us till now.

Sheldon King-We respect the family members. We finally have a meeting, we've tried to have a meeting for two weeks.

Lisa Just-We have been dealing with this since January. We've done this twice. We've gone through the whole procedure. He was the only one that met all the requirements and had all his paperwork in. Now it is September 17th. You could have given us a written explanation. We still are a working unit, the people still have needs. We want our own lawyer to deal with our issues.

Vice President Fisher-If you look at the letter from Sharlene, dated April 18, 2018. In addition, the programs have that discretion to be utilitized for their best interest. I feel like we're trying to debate something that we should be moving forward instead of moving backward.

Dana Eaglefeathers-Before the Chestnut did have a specific attorney that dealt with tribal health. This is the first time you have approached the Council as well.

Sharlene Evans-We wrote letters.

Lisa Just-This is the first time, we're all serving the same people, not ourselves. By the same token, we're open to your suggestions. We're a transparent board.

Dana Eaglefeathers-You have liaisons, they could have come to us.

Sheldon King-You have two liaisons. We need to move forward fast. I see Mr. Littlemouth over there all the time but we don't hear what's going on over there.

Sharlene Evans-We are here to have action on this today.

Merlin Sioux-I make a motion to table. There was non deliverables.

Sharlene Evans-We would like to know what that has to do with this?

Lisa Just-What does this past business have to do with tribal health?

Darlene Soldierwolf-Why are you against him? Because he's educated?

Sheldon King-No, what we're saying is that we have a lawyer that we pay for already.
