Kyle Alderman: I would just like to apologize for not finalizing or reviewing this, but there are a couple changes before we get started. On page 3, at the very top, it says "THEREFORE BE IT FURTHER RESOLVED that the Northern Cheyenne Tribe is willing to consider developing any potential energy and mineral resource discovered." That entire section needs to be taken out. And then, I would also like to add language in the "THEREFORE BE IT RESOLVED that the Tribal Council authorizes submission of the 2022 Energy and Mineral Development Project (EMDP) grant proposal to the U.S. Department of the Interior, Bureau of Indian Affairs Division of Energy and Mineral Development to fund planning for the further deployment of solar energy combined with energy storage on the reservation including at Tribal-owned buildings, residences and utility-scale instillations" and I would like to add "community sites" there.
