William Walksalong: Good afternoon, Tribal Council. It's been a long time since I sat before the governing body. I appreciate your time with this issue I'm presenting. I was contacted last week by Anna Martin, she's the Staff Assistant on the House Committee on Natural Resources. She's on the majority staff for Congressman Grijalva. He's the Chairman of the House for Natural Resources Committee. About 2½ to 3 months ago, I testified before this committee and the U.S. Congress and also Northern Plains testified. We testified on the litigations that the Northern Cheyenne Tribe has been involved in since the Killsback Administration. We sued on the ground that there were inadequate or no consultation with the Tribe by then Interior Secretary Ryan Zinke. The Tribe filed suit and the main lawyers that were handling the case were Jenny Harbine from Earth Justice. Some of the discussion was on the lack of consistent government-to-government consultation. How the Clinton Administration, the Bush Administration, and the Trump Administration, and even now the Biden Administration, handle the government-to-government, there's no consistency. In my discussion with the aid, Anna Martin, they're introducing H.R. 3587, it's called the RESPECT Act. The RESPECT Act is an acronym for Requirements, Expectations and Standard Procedures for Effective Consultation with Tribes. It

was scheduled for markup and they were calling for Tribes and other organizations to submit letters of support and since we have been a major player and are even in litigation, they are holding the hearing next week, April 18th, on our Coal Litigation, so this kind of ties in with that. But I had a draft letter, it was reviewed by the President and she signed it and we sent it back to this aid for the Chairman of the House Natural Resources Committee [reads letter]. They requested a resolution of support, and that is what is before you. That was given to the President's office on Thursday, and I drafted this resolution. The concern according to Congressman Grijalva's aid is that if they lose majority in the House, that this will never pass. But right now, they have the momentum and support to get this passed through the House Committee of Natural Resources and they anticipate that it would pass a full vote of the House of Representatives and move it on over to the Senate side. It was scheduled for markup and the aid requested that if the Council reviews and approves this resolution, to get it over to their office as soon as possible. If you read the detail in the act, it requires the federal agencies to have a point person to implement this formal government-to-government consultation and to train them and established and carry out consultations with tribal governments. Some of the reasons they noted in there, during the Trump Administration, they took action on the Bear Ears National Monument without consulting Tribes and having sacred sites on that national park, there. Also, the Keystone Pipeline, they tried to speed it up, the consultations with tribal governments. They had major budget cuts to the BIA, and didn't consult with Tribal nations. The last example was they mandated in-person school openings for BIE schools without consulting Indian Tribes during this pandemic. For us, we requested a consultation with Ryan Zinke when they were going to continue to offer federal coal leases for bid. That's how we ended up in litigation with the U.S. on that case. The Ziontz Law Firm wrote letters to Zinke asking for government-togovernment consultations on the impacts to the tribe and climate change. So, we ended up partnering with Earth Justice and we brought suit against them. It's the same thing, lack of consistent tribal consultation. So, there are several...there are non-profits and other tribal nations that have submitted letters of support similar to, and a resolution, similar to the one that is before you. That is briefly what this is. It would be a historical thing, it adds a layer of bureaucracy, but it protects our interests. They would have a tribal impact statement, just like an EIS. It would be codified under U.S. code, and that's what they emphasized when I spoke to this aid, Anna Martin, that it would codify government consultations. They're pushing hard for this in the House side.

It would be interesting to see who's going to show up at this hearing. Probably a lot of energy companies—the coal mining interests and others that are

opposed at advancing tribal interest. So, I would encourage you to attend that hearing. At least two or three of you.

Norma Gourneau: I plan on going.

William Walksalong: And I asked Wyatt Golding to send the details of the court room and address, and I'll get that to you who will attend. Thank you for your attention, aho.

Norma Gourneau: Madame President, I wish to get a clarification. So, you're advocating the sole source of this?

Colton Small: For the final design, yes. Since they completed...

Norma Gourneau: I just want to make it a matter of record that you're advocating the sole source. And then the other thing is that on this contract, before we vote on it, I would like to see the names of those people that are going to be authorized to make changes on the task orders—who's going to represent the Tribe. So, I would like to do that right now.

Colton Small: Okay.

Phillip Beckman: I thought an RFP was put out on all this stuff. Big hoorah about everything.

Norma Gourneau: It's blank, Phillip. I want it filled in.

Phillip Beckman: I'm not talking about that, I'm talking about the whole prospect.

Norma Gourneau: Okay, I just want it on record.

Lane Spotted Elk: I think the Tribal President would be the owner.

Debra Charette: Wouldn't that be Renessa?

Norma Gourneau: So, the owner is the Tribal President? And the representative for the task orders would be...?

Colton Small: I'm not sure if it would be someone from Childcare or if it would be the ARPA Director. One of those two, I-would guess. Or-both.

Norma Gourneau: Are we bypassing the procurement officer?

Debra Charette: Is that who signs all of the task orders, or no?

Serena Wetherelt: Well, she would get all the task orders.

Norma Gourneau: I would like to see her name on here. That's who we're designating.

Diane Spotted Elk: Renessa, in procurement.

Norma Gourneau: This thing that we're working on is blank, I want it filled in.

Diane Spotted Elk: Okay, I see.

Colton Small: Just to be clear, this is just for the design. I'm not sure how the procurement was for them to do the preliminary because their grant application was due right away, and so that's how Alaska and KLJ came up with that. And that's how they got the grant funding based off of that. I think that's why they're wanting to sole source to them, so they can finish their preliminary design, but the construction will still be bid out, normal.

Norma Gourneau: Either way, it doesn't matter if it's just design, or actual construction. What . we're saying is this Craig is going to be the representative for all the task orders, but there should be some input on the Tribal side if those are okay. And that's all I'm saying is, who's going to be that individual, on the Tribal side.

Colton Small: Renessa, wouldn't it? Procurement officer. She signs off on all of them.

Serena Wetherelt: Mm-hmm, there's a task order that needs to be changed, more or less. That would usually go to Renessa.

Colton Small: Yeah.

Lane Spotted Elk: Madame President, Colleagues, I think this is really an exciting project, and I really have to commend the childcare program for seeking additional funding and writing grants, and they've been on top of this. They've been really advocating for a new building and I know this will help your work in providing services, and helping childcare providers, so I know that out of the \$4.2 million, they've come up with a majority of that. So, I think that's really commendable. The Director as well. She couldn't be here today, but I really think that something like this really can enhance our community and service delivery for our childcare providers and our staff. They do a lot of work over there, so I think it's a good way to support them as well. With that, I'll make a motion to approve this resolution. Is it the final design? Can it say "Final Design" at the top?

Colton Small: Yeah.

Norma Gourneau: Just so I'm clear in my notes, who did we designate for the task order on the Tribal side?

Colton Small: Renessa.

Melissa Fisher: I do believe it would be Renessa and the contracting officer, who would sign off on the contract. So, the President would also have input.

Norma Gourneau: We already have her name down. So, it's Renessa.

Serena Wetherelt: Yes, the contract officer.
