DISCUSSION:

President Wetherelt: I guess I would just like to add a resolution that I'd like to present on our language nest resolution. We have a grant for \$50,609 dollars that was being worked on from a former previous council member and they never expended any monies on it. So, what I wanted to do is, I wanted to transfer this to the head start program so that they can use it and address our language preservation and being able to allow for all of the head start centers to be able to have this privilege. So, I'd like to add it onto our agenda.

Councilwoman Charette: Has that budget been passed through budget and finance first?

President Wetherelt: Yeah, it was already done. Remember this is the one that Diane was doing and I guess we never did really get no updates on what was going on with it. She did have meetings and everything but there was no expenses to it. They never expensed anything on that grant.

Councilwoman Lonebear: The reason I put it on the agenda is because I don't know how the council can try to, I guess to track it. I guess track the progress because thousands of dollars have been dumped into different programs not necessarily under the tribe but for language specifically and without success, to be honest. So, I would like to see, I don't know, someone that's ambitious I guess to push it forward and to, to make a difference because unfortunately I'm one of the ones that don't speak our language and barely understand the language.

President Wetherelt: Yeah, I met with Roberta and we wanna hire somebody. We'd like to get it advertised and do a curriculum for head start because there's only two classes right now that sure that have Cheyenne speakers. But this person would be able to go to all of the centers. They would be able, we'd be able to apply for another ANA Grant that's like for five years to sustain that so it would be continued. I think, in my own opinion that, I think that's where it needs to be. That's where I'd like it to go because it's gonna continue and those the children are already learning right now. I think we may, it's kind of a, this grant is going to end September 30th but we're, but we do need to, we need to get the grant going so that we can expense it out by then.

Councilwoman Lonebear: If there's any other ANA grants, I was approached by someone that works at the Lame Deer School, that asked if the Tribe could help get a grant for the school

specifically but I'd like to see it in all of our schools because I think Colstrip actually had a better language program than Lame Deer School did when they won that language bullet the college one year. It's, it's crucial.

President Wetherelt: I know when Mildred Red Cherries, I don't know what kind of grant she had but I know she really did a good job at Lame Deer High School and those kids could speak it.

Councilwoman Fisher: So, do we have a motion on the floor?

Councilwoman Lonebear: I'll make that motion.

Councilwoman Little Eagle: I'll second it.

Councilwoman Fisher: I didn't mean to interrupt but that was just to get it on the agenda then we could have more discussion when it comes up. So, the motion to add it, it will be item number 18.

Discussion:

Jason Whiteman: Thank you. I am here for a resolution of support from the Tribal Council for the proposal for FY23, fiscal year 23 to be submitted to the BIA and it's, it's the category for attorney fees and mainly that involves, it's for protection and the attorney that we use to protect our natural resource assets. That's the main purpose of that. The amount will be for \$35,000. There's one section that needs to be corrected in here. I received an e-mail from the regional office about sections in here so there's one correction I need to make under the proposal here. Also the attorney fee cost used to be \$225 and it's down to \$200 per hour so that is the other correction that I need to make. Let's see what else. Ok that's the main thing. But the deadline was on the 13th, I submitted an unsigned copy to the regional office to meet that deadline by the resolution and the cover letter for the proposal. I only had a four-day notice; five-day notice on it. Friday, we got the notice and the deadline was this past Friday to get attorney fee proposal in. So, then I did that again with that. Then if the council approves of this resolution then I'm requesting the President to sign that cover letter. And if it gets approved to and to sign the cover letter as well as the resolution process as soon as possible. That would be through Dina here. Those are in the simple terms but it's just a proposal and if we do get funded for it then the natural resources, it'll be coming in a grant form and the natural resource department will administer that grant. We've been doing that for decades.

Councilwoman Fisher: I'll go ahead and make that motion.

Councilwoman Gourneau: Go ahead, I'll second your motion.

Councilwoman Charette: Ok. I was just gonna ask, it's for \$200 and not the \$225?

Jason Whiteman: Yeah, it's not \$225, it's \$200 dollars. That's the federal guideline, BIA guidelines. I forgot to mention, excuse me, I'm sorry to interrupt. We used Jeanne Whiteing's credentials for the attorney fee grant application here. So that's the only thing. Could I make one more request, again I am interrupting. I don't know if you got the message last Friday. The regional office requested to exclude Jeanne Whiteing's driver's license from the application, grant application. When I sent it to you last week the Jeanne Whiteing', no personal information

be in on that. So, just remove the driver's license part of it out of the application. Usually we do that but just internally we do that.

Coucilwoman Fisher: Item #5, Headstart Policy.

Secretary Restar: When I did talk to her on Friday, she said she has a staff meeting at nine but she thought she would make it in time.

Councilwoman Fisher: Just go ahead and move her down?

President Wetherelt: Yes.

Councilwoman Fisher: She has 2 of them so we will just move 5 and 6 down. Since I.H.S. is here, we will proceed with him.

President Wetherelt: She may be here by then.

I.H.S Update:

Damion Killsback: Good morning Tribal Council. I apologize, I thought the meeting was tomorrow. I looked at my calendar and I had a meeting early this morning with the Bureau of Indian Affairs Corrections Director about youth detention facility. So, just a few updates, I think on the agenda I said, I sent to Edina yesterday, last week. Last week we did experience a threat from a patient. It was called in as a code silver, which was an active shooter event from a threat from a patient. So, we instituted a lockdown; modified lockdown for rest of the week which convened this past Friday to have all security, working with tribal security we debriefed them to make, to have all the patients coming in and entering the building at the main entrance. Also making sure that they used the security and patient registration to make sure that they're there either for an appointment, see a provider or even our insularity services. That is what was established last week. We are going to be having some partnership with the security, tribal security, to have some trainings for the security officers and our staff on how to recognize, how to de-escalate those types of situations in the future. We have them in place but one of the other things I wanted to communicate with the tribal leadership is that we are severely short staffed now. We are down to 1 full time urgent care provider and a half time urgent care provider right now. So, we are actively recruiting. We do have a few providers coming on in March, but it doesn't really address our immediate needs right now. For the month of January, we have some uh some gaps in our urgent care schedule for the remainder of the month starting next week. So, we are working with the Billings area office to try to get some staffing in, either from Crow or across the other IHS service units but they're in the same situation. They have, we're trying to exhaust our provider contract urgent care providers to cover our urgent care departments. So more to come with that. Technically we're not designated at urgent emergency department, we're designated urgent care but I do like to try to keep our urgent care services available 24/7 so I don't want to have to close our urgent care for anytime at all. So, we are looking at the possibility of that, real possibility having to close our urgent care for at least in a few hours in the wee hours of the morning where we have the lowest, the lowest patient density should be between 11:00 PM to 7:00 AM in the morning. That's our lowest patient density in terms of user population utilizing urgent care. So, I just want to make sure I communicate that with you guys

right now before if, it may come to that. We're still looking at filling in gaps of our provider schedule, but I did want to, in the spirit of transparency that that's something that I'm looking at that I might have to do. I've talked to our area leadership, and this is a national crisis across Indian Health Service. So, right now our area director is actually, was meeting with the all the area directors for all 12 IHS service areas in Alaska last week and areas that were, I guess not as dire, did not have the dire needs that we have, such as Phoenix and Oklahoma and Navajo area all have similar situations of staffing for providers in urgent care departments are really across the country, not just the IHS health delivery system I think even in the private sector are really experiencing a shortage. So, I just request that you guys just believe that I'm going to do everything I can to make sure our doors are open and if it comes down to I don't want I'm trying to make sure that we have coverage but at the very minimum maybe we have to look at closing for those wee hours of the morning and then have transports go straight to Crow, if necessary. So, that's where we're at right now with that.

Councilwoman Charette: Ok, but you'll let our director know.

Damion Killsback: Yeah. She was on the email that I sent out last week about looking at the

Councilwoman Charette: Because she'll have to get with our EMS and everyone if that's where they are going to be going and start scheduling. Probably gonna be a change for your department to schedule ambulances to go to Crow if they shut down.

President Wetherelt: So, if there is an emergency?

Damion Killsback: If we're closed, we're gonna have to divert. Potentially, if don't have staff for coverage, the diversion will have to go to Crow for Urgent Care. We will make sure Crow is aware of that. We were trying to get their doctors to come and help us but I haven't got a response from them from the past 3 emails that I sent and calls. We'll have to have a diversion to Crow for our really urgent care patients that need services. Yeah, that's the reality of our situation right now is we just don't have the staffing. We tried, we're actually recruiting. We actually had a, brought her in last week that is an Urgent Care Urban trained doctor. We tried to bring them on. They came thru their first site visit last week to look at our facility and our community. So, hopefully that will help us in the long term get an urgent care provider in our facility. So, more to come with that. I'll keep you guys updated on how that plays out. That was the site visit we had last week. There is still some negotiation going on. They are actually at another HIS service facility right now. We would love to have them but we are gonna try to negotiate with them to try to get them on board if they are interested in coming. Question?

Councilwoman Fisher: I have a nurse, a RN, approach me about trying to get hired there. She said that she's been trying for a couple years. Well since she's been, she worked there during the emergency, she was an emergency hire during the pandemic and after her term ended, she finished her term and then she hasn't been able to get hired there. She is, she does live locally and this hasn't, she hasn't got a response back.

Damion Killsback: Yeah, I did respond to her before earlier. I saw the e-mail from her last week as well but we're in the same situation with the certification. They are a non-tribal member

they're not enrolled here and that that's one of the caveats. The other caveat is that that she does not have a four year nursing degree, she has associated of nursing degree and that requires that one year experience program outside IHS to qualify for one of our nursing position. So, that would

Councilwoman Fisher: But she provides for her children. Her husband's a Cheyenne and her children are Cheyenne.

Damion Killsback: Well, I understand that. The things that

Councilwoman Charette: The contract time does that not count towards it too?

Damion Killsnight: No, it doesn't. She has to get experience, actual

Councilwoman Charette: You want to hire her but her time with the IHS

Damion Killsback: Yeah, you see, it has to be like a full year of nursing experience outside of our facility. That's one thing, believe me, I'd love to have her if I could bring her but that's one thing that my hands are tie on. I actually have talked to the area nursing consultant at Billings; had my DON work on this and I just can't help her right now cause my hands are really tied. The things that we can look at is if we can have, I don't know if you guys can do a resolution to make a recommendation to that then we can probably look at how we can lift some of those you know, cause there's things the council can for non-tribal members like if there's a non-member here that wants to be seen for health care services, a tribal resolution from the council would say we'd like this individual to be seen at the IHS.

Councilwoman Gourneau: Isn't there a waiver policy in 638 where you can request a waiver. I think we should do that.

Damion Killsback: There's no waiver process for those types, for like on boarding physicians. The only waiver that we would have would be like, for like a tribal member that could be considered for a position that they are already in for like a lateral transfer or like a

Councilwoman Gourneau: I'm not talking about that. So, we have an individual and she has credentials. Maybe not the high level that you want but she has credentials so can't we request a waiver of that one year?

Damion Killsback: Um, so

Councilwoman Gourneau: You know what, we are gonna do that and then, we'll just do that and then IHS can deal with that.

Damion Killsback: Yeah, yeah.

Councilwoman Gourneau: I have another question. This is a serious issue. What was OJS's response when they had that individual in ER?

Damion Killsback: Which individual are you referring to?

Councilwoman Charette: The one that made the threat.

Councilwoman Gourneau: The one that made you shut down.

Damion Killsback: OJS. We had the BIA come in and they actually, first individual requested. At the time, we requested that he be watched because he was still seeking medical care. He was just making verbal threats and at the time he, I guess there was escalations of previous experiences with this individual that I wasn't aware of. I was out dealing with my clinical staff and provider and nurses. When he made his threats, our provider and our nurse felt so threatened that they called in a code silver then our provider just left the facility immediately, the nurse that was actually tending to him. That was the information that I got. Bureau of Indian Affairs police were called but I guess there was a power outage. So, we have a button that triggers the call system for Bureau dispatch but that was inoperable because of the power outage last Monday. So, they actually had to get ahold of, I think one of my nurses had the cell phone number of one of the officers. I think her name was Johnson, I think, I can't remember her name. They came; they did a brief interview with the patient and basically, he was threatening our employees.

Councilwoman Charette: Was he arrested?

Damion Killsback: He was arrested. Yeah, he was arrested after

Councilwoman Gourneau: Wait, I want to hear what he has to say. I want to hear what you have to say.

Councilwoman Charette: Go ahead finish, sorry.

Damion Killsback: So, he was there. He was in our waiting room for some time and the BIA police left and our security was supposed to be watching him while the, can't remember who it was, what his name is. Well, I know what his name is but I don't know what his title is but I don't think he is BIA. It was John Grinsell who came and arrested the individual and detained him shortly after the BIA police left.

Councilwoman Gourneau: Ok, that's the point that I wanted you to point out. Law Enforcement, OJS, was called. They went over there, right? And then they left, right?

Damion Killsback: Yeah.

Councilwoman Gourneau: And then the Tribal Criminal Investigator came and arrested him.

Damion Killsback: Yeah.

Councilwoman Gourneau: But the point I'm trying to make is that OJS had a job to do and they went over there and didn't do it. So we had now, you implemented a lockdown which

harmed our people because they weren't eligible or they couldn't go to the clinic to receive care that they needed. I was getting calls saying that they were there but they were on lockdown and I can't go over there. It's real disappointing, just so that everyone knows, they continue to neglect their duties of OJS. Now, we have had Chief of Police and other people say that a lot of the OJS officers go to ER and they sit there and visit with the nurses and eat pie instead of being out in the community. I wanted to bring that up because having a modified lockdown at IHS, when you are so short staffed anyway, just adds more hardship for our tribal members. We really need to thing about those things. BIA Law Enforcement not doing what they are supposed to be doing. They should have taken that individual and arrested him and did something with him so he wouldn't continue to harm or threaten your staff.

Councilwoman Charette: So, your staff would feel safe. I mean, it shouldn't of had to take our tribal people to come in and do it.

Damion Killsback: I appreciate that. I mean that's, I don't know. This is the first I've heard of these situations with OJS. I don't know what that dynamic is with the Tribe. I'm starting to really understand the dynamics with our facility. Just to be clear, a modified lockdown does not mean we're locked down. All it means is we have one central entrance and that's the main entry point for everybody to come in and out of the building. It's not that we are closed or limiting services. All it is is all our peripheral entry points are locked. So, we can't come in the back or the 2 side doors. Everyone has to come in main entrance. That's all that means for modified entrance. That's all we did for the modified lockdown. I know it seems like it's a lot more, like we're closing down services but we're not. We're just making sure that every single door in the building that has key coded has been locked.

Councilwoman Charette: And that's for the safety of your workers. You know, we hear all these things out in the community. Our security, tribal security is trying to keep your business safe and you're trying to keep your employees safe. Ok then, the one who came in and made the threats, if I hear right from what's out there, OJS was asked not to arrest him and to go ahead and let him finish with his medical care. When this threat is made, that individual should be taken care of and arrested. I'm hoping that's not any truth to that because you're responsible for your staff and we are responsible for our staff and their safety.

Damion Killsback: Ok, I think there might have been some miscommunication. Go ahead Melissa.

Councilwoman Lonebear: My question on umm, you mentioned the Crow, you requested doctors or ER urgent care help from Crow and Northern Cheyenne hospital, and they didn't respond.

Damion Killsback: Yeah, they haven't responded to me yet.

Councilwoman Lonebear: How can we, that's not acceptable.

Damion Killsback: I realize that.

Councilwoman Lonebear: Can't you reach out to the region.

Councilwoman Charette: The region should be able to say, hey, you're gonna go be detailed over here.

Damion Killsback: They are looking at other contracting physicians from other areas like Wind River was one down in Wyoming to have come staff our facility. So, we're also looking at Blackfeet and Ft. Belknap areas to have some staffing. So I'm, so I'll follow up with them today of course. Obviously, I'll keep you guys aware; the Board of Health director aware what the status of that is. Like I've been, I'm doing everything I can Melissa I really am and I really

Councilwoman Lonebear: What can we do to help because we can't have our ER closed. It's to dangerous. What can we do on our end to help?

Damion Killsback: Yeah, I think that the weight of your guys' concerns is definitely, I understand that. If you had like a, I don't know, an e-mail resolution I could send it up the chain to the Area Office, I would say like something like this, the council is really adamant about this and we really need to do something about this. Because I know I am the CEO, that's my role to operate the NCSU but and you guys are tribal leadership, you guys are government and they need to listen when you guys say something then IHS needs to take that seriously and do everything they can to accommodate that. I would definitely get that message to them. I've been on the phone, even after hours, with the area director last week and I'm trying to work with them as best I can. There's a staffing shortage across all the Indian country. I've even put in my own services as a pharmacist to help staff my pharmacy. I have two pharmacists now. So, that's one of the things I have to consider is going and working in the pharmacy for a couple of days a week to help with my staffing there. So, we're doing everything we can and I know that's not going to help keep our doors open if we don't have the staff to do it. If you guys want to send me an e-mail and I can send it up the chain, I'll definitely let the area director know of the urgency that you guys want to communicate with them.

Councilwoman Gourneau: Madam chairman because I think this is so serious, our healthcare is very, very important and so I would like to make a motion that we send notice to the Indian Health Service, the local and all the way up the chain of command to say we are very disappointed in the seriousness of the short staffing at the IHS and that we want their help to get something going for our community. I think it would different if we lived, if we were closer to other health facilities so we would have options, maybe to go somewhere else, but we don't. We're very rural. Councilwoman Gourneau: I just want to point out a few things on the Forest Management Plan. This is, I've read the document and it's very well written. What you need to understand though is one of the main differences from the previous plan to this one is that we're changing our million board feet that we're going to cut per year. So, I would like to read it. It says the forest management plan uses the latest forest inventory analysis completed in September 2018. That was for the harvest of 4.7 billion board feet of timber per year. So, that's a decrease from 6.8 and if read through this it tells you why they're doing that. I like the recommended alternative and it talks about having a real healthy forest and all the work that we're going to be doing out in the field. So, that's a good thing in the plan. The other one is, there was a survey done and I just wanted to point out the public opinion, it says issues of greatest concern to tribal members were found to be employment, water quality, tribal income and wildlife habitat. I'm glad you've included this in the Forest Management Plan. So, with that I make a motion.

Councilwoman Fisher: Thank you Terry.

Councilwoman Charette: Thank you Terry.

Councilwoman Gourneau: Thank you Terry. Thank your staff and the BIA for all their hard work.

DISCUSSION:

Councilwoman Fisher: A resolution of the Northern Cheyenne Tribal Council prioritizing and allocating local assistance and tribal consistency funds (LATCF) for general revenue enhancement programs.

Whereas, The Tribal Council has received fund from the Local Assistance and Tribal Consistency Fund whose purpose is to serve as a general revenue enhancement program and recipients have broad discretion on uses of funds similar to the ways in which they may use funds generated from their own local revenue sources; and

Whereas, the Tribal Council is allocating \$3,247,637.00 of its Local Assistance and Tribal Consistency Funds for the following projects and initiatives which will improve delivery of services to our communities and to maintain and expand public services; now,

Therefore be it resolved that the Northern Cheyenne Tribal Council hereby prioritizes and allocates Local Assistance and Tribal Consistency Funds, received from the U.S. Department of Treasury.

Councilwoman Gourneau: I was just telling him that our cash program match, generally all of those funds come out of the permanent fund. So, we're moving those funds to be paid out of this account. It will free up funds in the permanent fund for other purposes and we've left that blank. We haven't made a decision on any of that because we know that there's a lot of need; there's a lot of interest in doing things for our elderly, our teens, our youth. Their spending is going to be available in the permanent fund.

Vice-President Littlemouth, Sr.: So, the permanent, this is where the money is going on these?

Councilwoman Gourneau: Yes, from this fund.

Vice President Littlemouth, Sr.: Why are there no youth on here? Language?

Councilwoman Gourneau: Because the youth, the youth is paid out of the permanent fund. So, because we are going to pay for these, it leave money in the permanent fund. So now we are going to have to develop a budget on the permanent fund.

Vice-President Littlemouth, Sr.: You guys got good buildings for Busby and Muddy. What are you guys gonna add next?

Councilwoman Charette: We still need to have them remodel for the equipment that was bought.

Councilwoman Gourneau: Because Ashland and Birney got theirs remodeled so now, Muddy and Busby are going to get theirs remodeled.

Councilwoman Fisher: When we had that CARES money, we bought that kitchen equipment. The same equipment for all the halls. Busby and Muddy halls need their kitchen equipment installed. I know Muddy's needs some roofing issues and some other stuff that needs to be fixed.

Councilwoman Gourneau: And Busby's needs a bathroom.

Councilwoman Fisher: Their halls need to be renovated and the kitchen equipment needs to be installed.

Councilwoman Charette: And hers needs a bathroom first so they can have water so they can have a restroom inside the hall.

Councilwoman Fisher: At the time when we were making those decisions, Lame Deer District was getting a whole new hall so all of that was included in there, the plans for the kitchen and stuff that's why we didn't get the kitchen equipment and stuff for Lame Deer because they were getting a whole new hall or getting one built.

Councilwoman Lonebear: So, these are buildings that already existed and all this money is being dumped into them. It was before our time but, Donovan and I were talking about it this morning. This is the hub; this is the hub of the reservation and Lame Deer does not have a community hall and we're restricted from using these other buildings for different reasons. I mean not like accessible enough for membership. Is there plans for a hall for Lame Deer or was there money allocated and is it still there? What do we need to do to?

Councilwoman Gourneau: We have drawings, today we have schematics and everything for the Lame Deer hall.

Councilwoman Charette: And what happened was that, there was the question of where are they gonna put it? Everybody wanted part of that and so then that kind of got taken off. Then we were trying to put it in with the food bank and then that also got changed. Then we were having, there was so many other ideas out there that it just didn't work.

Councilwoman Gourneau: We do have a schematic if you guys want to look at it.

President Wetherelt: What about this, where we were gonna have the umm, just right across the street here where we were gonna have the Justice Center. Could we put it there?

Councilwoman Gourneau: Well, there's room there and there's room across the street too.

Councilwoman Lonebear: But is there's still money somewhere for this?

President Wetherelt: They did put aside \$1,000,000 dollars for it.

Councilwoman Charette: No.

Councilwoman Friesz: I thought it was \$100,000.

President Wetherelt: Oh, was it \$100,000.

Councilwoman Friesz: The last ARPA funds that we had. I think it was \$100,000 that was

allocated.

Councilwoman Charette: Yeah, and then like Torrey had a good idea about the commodity program too. If that building was not going to be used to renovate it and use it as a hall.

Councilwoman Lonebear: We need something bigger. Right across, you know when you first

go in.

Councilwoman Charette: Yeah.

President Wetherelt: We could probably put it there across from that shade part, yeah. But they wanted extra showers, kind of like, you know, for people like during the pow wow that can go there and shower and stuff.

Councilwoman Fisher: So, the schematics, the plans that we have, how much was it?

Councilwoman Charette: I can't remember.

Councilwoman Lonebear: Who has them? Ranessa?

Councilwoman Gourneau: No, Colton does.

Councilwoman Fisher: Colton has them.

Councilwoman Lonebear: I'll take a loot at them.

President Wetherelt: If we need more money, I think we should kind of be a priority since we

don't even have one.

Councilwoman Lonebear: It needs to be a priority.

Councilwoman Fisher: Yeah.

President Wetherelt: Yeah. I think some of this, we could take some of the some of the, well like this Housing Authority payment, \$89,000. I don't even know if we have anything in writing on it.

Councilwoman Charette: We have to negotiate. That's what the council will do.

President Wetherelt: Yeah because it's umm. You know, if they have stats of when they used them. Because like Birney, Gwen told us that they've never used Birney's. You know, I guess it was available but nobody, they never put anybody in there.

Councilwoman Lonebear: Well, that's a good question. I went to one housing meeting and there is a meeting tonight that I can't make. So, whoever the other liaisons are should probably go.

Councilwoman Charette: I'm going because I want to propose

President Wetherelt: Yeah because we should have some business stats. I know that Lame Deer's got used quit a bit.

Councilwoman Lonebear: We have homes that aren't lived in. We have people that need homes and those home need to be lived in.

Councilwoman Gourneau: And that's what Debbie is going to talk to the Housing board about tonight.

Councilwoman Charette: Because there's stuff not done that was on our side and there was agreements on those and then stuff that was not done on their side. This is the middle ground so we can all start over at zero.

President Wetherelt: Yeah.

Vice-President Littlemouth, Sr.: What's this buffalo contract?

Councilwoman Gourneau: We put aside money to manage the buffalo. Then we put aside money to manage the, umm.

Councilwoman Charette: Fish and wildlife.

Councilwoman Gourneau: the fish and wildlife.

Councilwoman Charette: Trying to gear up so we can

Vice-President Littlemouth, Sr.: Fish and wildlife, is that a umm.

Councilwoman Charette: That'll be something new also.

Councilwoman Lonebear: That's one of the things, we have to take those regulations out. We have to get this moving.

Councilwoman Fisher: So, we can clean up our ponds and plant new fish. Just get our recreation areas cleaned up. I'm for that because at some these events you know, people go out there and fisher and walk and look around. It used to be a beautiful place to be but now you know, people go out there and make a mess.

Councilwoman Charette: Same with the Busby water. We've looked at the water. We've seen examples and pictures of the water also. Something that we are looking at.

Councilwoman Fisher: Our water ponds need to be cleaned out and made healthy again so we can get new fish in there and make it look nice again.

Vice-President Littlemouth, Sr.: So we are hiring a manager for the buffalo?

Councilwoman Gourneau: We haven't hired anybody.

Councilwoman Charette: We haven't hired nobody. We are trying to get started but we need a budget to get started. That's with all of these, we need a budget.

Vice-President Littlemouth, Sr.: The thing we need to really start looking at is these buffalo right now. Like Donavin bought some hay for them. Ask transportation if they can fix a road out there. Hopefully they can fix the road and start feeding them.

Councilwoman Fisher: We need to buy more feed; we need to fix the fence; we need to put more water out there. You know, there's a lot of improvements and stuff that we need to do to take care of them.

President Wetherelt: Yeah, I don't think there's been a recent count either. After they all had babies. We had a count before then and now we have no idea how many new buffalo we have.

Councilwoman Fisher: So, it'll good be to have somebody out there.

Councilwoman Charette: Yeah, since it was brought to our attention, that's what we figured part of this money would be good for is the buffalo, fish and wildlife, for water. Then, also our employees on the 401K. So, we are looking at a broad band of different programs that need money and that's what this budget is for.

Discussion:

Councilwoman Gourneau: Madam President, Vice President and council, I have before you a resolution that would establish a legacy fund to assist the tribe's senior citizens. Through Resolution No. 042 (2021), the Tribe established that tribal members who have reached the age of 60 years are considered a senior citizen (elder) for purposes of eligibility for services and/or other benefits they are entitled to. The Tribal Council of the Northern Cheyenne desires to develop and maintain a Fund similar to the Northern Cheyenne Permanent Fund which was established to provide a source of income to assist the Tribe to protect the health and general welfare of the Tribe. The Tribal Council of the Northern Cheyenne will establish a fund that will be specific to assisting those tribal members who are deemed senior citizens and that the fund shall be titled the "Legacy Fund." The Northern Cheyenne Tribe received a settlement from the Ramah Settlement Indirect Fund and a portion of those funds shall be used as startup funds for the Legacy Fund.

THEREFORE BE IT RESOLVED, that the Northern Cheyenne Tribal Council hereby establishes a Legacy Fund from funds to be set aside from the Ramah Settlement Funds with said funds to be invested by an experienced trust fund manager; and,

BE IT FURTHER RESOLVED that the Tribal Council shall develop policies and procedures concerning the establishment of this Fund and that funds are to be held in principle and only the interest, dividends earned from the investments shall be used to issue payments to the senior citizens of the Tribe in accordance with the Policies established for the Legacy Fund.

That is my motion.

Councilwoman Lonebear: One question. Who will develop the policies and procedures?

Councilwoman Gourneau: The council and the attorneys.

President Wetherelt: So, you're not gonna like, if that's all your gonna

Councilwoman Lonebear: Just an advisory committee so we can and I didn't get a copy of

President Wetherelt: Are you going to like print applications and see or what is the, what is your policy?

Councilwoman Lonebear: No, to establish policies or to establish like a

Councilwoman Charette: Whatever policies they have in place that they followed.

Councilwoman Lonebear: That they are being followed and that the amounts that are given out are fair to the membership. So we can reach as many of our tribal members as possible. In the initial grant that I got a copy of, a lot of, I think the majority of it was for home mortgages which really doesn't pertain to our reservation. There are people who live off the reservation that need that assistance but not the majority. So, that's why we want to establish this committee.

President Wetherelt: So, you are going to give our local people, that live on our reservation, priority than the ones that are off.

Councilwoman Lonebear: I wouldn't say priority. But just so, like if there is a section for mortgages, there's a section for renovations, there's a section for energy assistance, for rent. So all the same amounts are given out per person rather than one person getting ten thousand dollars and another getting five thousand dollars. So, everyone is treated fairly.

President Wetherelt: William is not here today but I think he would, you know, if this is what you guys want to do, then I think, you know, you guys need to, because there is, they do have the guidelines for this. Maybe you guys

Councilwoman Charette: I think that's what we want to make sure is that those guidelines are being followed.

President Wetherelt: Yeah.

Councilwoman Lonebear: So, we could put him on for the administration side. He would be ideal for it.

President Wetherelt: Yeah, because he knows pretty much. He's the one that worked with treasury on all of that stuff.

Councilwoman Fisher: So, William for admin?

President Wetherelt: Yeah.

Councilwoman Charette: Who is the accountant? Which accountant is this under?

Councilwoman Lonebear: I don't know. Which accountant is it under? Do you know?

President Wetherelt: I think it's Terrance.

Discussion:

President Wetherelt: WHEREAS, the Northern Cheyenne Tribal Council passed Resolution No. DOI-084 (2021) that sets the restoration of the Cheyenne language as a priority, creates multiple task forces to create a comprehensive language restoration action plan and the Tribal Council authorized the Tribal President's office to coordinate the task force formulations which includes the Language Nests Project as a component of the comprehensive language preservation action plan for the Northern Cheyenne Tribe; and,

WHEREAS, the Tribal President's office has designated the Northern Cheyenne HeadStart Program to be the lead Tribal agency to implement the Northern Cheyenne Language Nests project funded by ANA; now,

THEREFORE BE IT RESOLVED that the Northern Cheyenne Tribal Council reconfirms the Tribal President's, or designee, authority to coordinate and implement the Northern Cheyenne Language Nests grant;

BE IT FURTHER RESOLVED THAT this Tribal Council action designating Northern Cheyenne HeadStart Program as the lead Tribal agency for the implementation of ANA grant award number 90NX0205-01-00 supersedes any conflicting resolution or ordinance.

Councilwoman Gourneau: I think it's a good idea. I just want to make sure that the Head Start is focusing on conversational Cheyenne rather than reading and writing and all of that. Because I think if our young people learn conversational Cheyenne, that's a better preservation of our language than waiting until they get into college to learn to read it. I just want to make sure that is a priority.

Councilwoman Fisher: Can she give us reports?

President Wetherelt: Yeah, she probably can. The first thing that she needs to do is advertise for the position and then meetings will start. Then we could initiate

Councilwoman Fisher: She only has until September so can you expedite the process?

President Wetherelt: Yeah. Once this gets passed, she can go ahead and advertise.

Councilwoman Lonebear: They'll only have how many months of classroom time with them?

President Wetherelt: It'll start, she's gonna try to get everything, cause the curriculum will need to be done. Then, so once they get that done and they order whatever

Councilwoman Lonebear: We need to give a deadline for the curriculum at least because now we only have

Councilwoman Gourneau: Well, Head Start ends in May

Councilwoman Lonebear: Yup, April, May and then half of August and September. That's only three and a half months left of this grant.

President Wetherelt: Yeah.

Councilwoman Lonebear: What else is pending? I mean, what else is just sitting there that we don't know about? That's why I brought it up because it was brought to my attention that that money was sitting there.

President Wetherelt: Yeah.

Councilwoman Lonebear: There's stuff that we're missing out on. They're asking different age groups. I don't know.

President Wetherelt: Well, they are probably going to run into the same thing too but once

Councilwoman Lonebear: No, it's our job to get funding for it and to figure out a program that's going to work because like she said the conversational Cheyenne needs to be taught. Especially with Head Start kids because they can't read yet.

Councilwoman Charette: Well, with this short time period, why is she just hiring one? Why can't she hire like

President Wetherelt: She can. That's why we put on here they can have volunteers. They can do volunteer. We talked about this and whoever gets into this and they can get volunteers if they would like but it would be full and they would go to one center each day and they would be taught the same thing.

Councilwoman Fisher: But, what I'm saying is school is going to end. Is she going to offer this service thru the summer?

President Wetherelt: We didn't talk about the summer, but we wanted to get everything done. She is going to apply for another ANA grant that's for five years and it'll sustain that.

Councilwoman Charette: Ok.

Councilwoman Gourneau: Just remember, for ANA, if we are not doing anything with this grant, we are not eligible for another one.

Councilwoman Lonebear: So, they have to meet their objectives and that's why they need more than one person.

Councilwoman Charette: She can hire three for that short time period. Three full time ones and just get them out there and start.

Councilwoman Gourneau: Really focus and just get it off the ground.

Councilwoman Fisher: You might just need to do emergency hire then skip the HR.

Councilwoman Gourneau: There are people in our community that have taken that State Language Certification. I don't know what's it called.

Councilwoman Fisher: But, with the short time frame, you could bypass the HR because we are in a state of emergency for language already by resolution. So, you could just probably use that to do your emergency hires rather than the long process.

President Wetherelt: Yeah, we could probably do that.

Councilwoman Gourneau: So, the purpose of this resolution is to transfer the responsibility of the ANA Grant to Head Start, right?

President Wetherelt: Yeah.

Councilwoman Gourneau: I'll make that motion.

Councilwoman Little Eagle: I'll second.

Councilwoman Charette: With a sense of urgency.
