ITEM #1- MONTANA'S MEDICAID STATE PLAN AMENDMENT

COUNCILWOMAN FISHER: A resolution supporting the State of Montana's Medicaid State Plan Amendment making the Tribal Health Improvement Program permanent. The 5th whereas.

WHEREAS, the Northern Cheyenne Tribe has participated in the Montana Medicaid Tribal Health Improvement Program since 2019 and finds that the program has significantly benefitted tribal members participating in the program; and

WHEREAS, the Northern Cheyenne Tribe desires to continue participation in the Tribal Health Improvement Program and to expand to Tiers 2 and 3 in future years; and

WHEREAS, the current authority for the Tribal Health Improvement Program is under a section 1115 waiver with the Centers for Medicaid Services ("CMS") which is set to expire in June 2024, and the State of Montana is planning to propose to CMS a State Plan Amendment making the Tribal Health Improvement Plan a permanent program in order to avoid disruption of services and loss of revenue; and

WHEREAS, the Northern Cheyenne Tribe would like the Tribal Health Improvement Program to continue without interruption or loss of reimbursement.

THEREFORE, BE IT RESOLVED, that the Tribal Council does hereby support the Montana Medicaid plan to propose to CMS a State Plan Amendment that would include making the Tribal Health Improvement Program permanent.

ITEM #2- RATES FOR GRAZING ON TRIBAL LANDS 2024-2028

COUNCILWOMAN CHARETTE: He wanted to just rescind the resolution.

COUNCILWOMAN FISHER: In the last council meeting we passed a resolution approving the grazing rate so we'd like to disregard that resolution and present this ordinance of the Northern Cheyenne Tribal Council approving and authorizing a 4-year grazing permit at the rate of \$12.00 on tribal lands. The permit period is February 15th 2024 through February 14th, 2028. Therefore, be it ordained that the Northern Cheyenne Tribal Council hereby approves and authorizes 4-year grazing permits. Be it further ordained that the Tribal Council of the Northern Cheyenne Tribe sets forth this ordinance and can only be rescinded or repealed only by affirmation vote of eight members of the Tribal Council. That's my motion.
