CAPT. DAMION KILLSBACK: Updates given on the following items:

- *Staffing
 - *Physical Therapist Resigned
 - *Supervisory Physical Therapist should be starting soon.
 - *Optometry Patients are still being referred to Crow.
- *Flooring Project Just about complete. 2 more rooms need to be completed.

- *Dialysis Center Discussions on the progress. Possibility of modular units being used.

*Syphilis Cases – Cases have gone down since the outbreak but there is still a huge concern due to all the events that are coming up in the communities.

SUPT. ANDREW WERK: Updates on the following items:

- *Richard Springs Fire
- *Probate: Business as usual with 18 cases heard.
- *Realty: TAAMS Lockbox up to date. Keeping it cleared out. Working on expiring Right of Ways. 200 Letters went out. Continue to work on compliancy. Regular business as far as homesites, land sales or farm pasture leases.
- *Right of ways & Broadband High priority. Need to be more responsive. President has Exteral hard drive with all right of ways on it. TSR's are also on there.
- *Self-Determination \$1.7 million sitting in Treasury. \$1.2 of that is FY 23 funds
 And about 500 thousand of that is FY 22 funding. Stongly encourage the Tribe
 To draw those funds down. As long as the funds are sitting in Treasury, the
 Tribe is not receiving interest for those funds. Processing Resolutions.
 Re-contracting of 638 Programs. Just a friendly reminder, the Single Audit
 Report due June 30, 2023.
- *Range We did go through the 1st round. Continuing to process invoices for that. 2nd round closed Friday. Applications from 2nd round will be sent to Grazing Board. Going to be having a 3rd round for sure. We did have orientation with the Grazing Board on May 18, 2023. It went really well. Definitely a need for updates to the ordinance.
- *Social Services Continue to have a heavy work load. No General Assistance (GA) due to funding. Continue to work with families on re-unification.
- *Fire There have been 8 fires this year. 2 by lightning and 6 are human caused. 45 AD's signed up that are getting fire ready. Rookie school next week. Readiness Review going on this week at the Agency. Prevention review last week. It went really well. Encourage folks in the community to be safe.

COUNCILWOMAN LONEBEAR: Send out another reminder that the fire restriction has not been lifted. Ceremonial fires will be ok.

- *Facilities Youth Correction Center: New well is being drilled and should be done by the end of the month. Also, the roof replacement for the Youth Correction Center is out for bid. I'll keep you folks updated on that. I know it's been a priority for the Tribe.
- *Vacancies We are making some progress. 1 Range Technician position that came out of classification and is at recruitment now. That should be advertised soon. Realty Assistant position that will be re-advertised soon. Forester position in Forestry will be advertised soon. 3 Social Services Rep. positions will be advertised soon. The 2 social workers that were hired should be starting this month. Also have a staff assistant position for executive

direction that will be submitted to classification for recruitment this week. Trying to get emergency hire for custodial work. Realty Officer position and Deputy Superintendent position. Trying to get that moving along also.

- *Clean up day Held on May 31st. Went really well.
- *Pathway student here this month. GIS related. Will work with myself.
- *Tongue River water users association meeting in Miles City last Thursday. Will meet Jason Whiteman and Jeanne Whiting for discussion on the water rights.

DISCUSSION: ITEM #9 - SMILES ACROSS MONTANA - KIM DAHLE

KIM DAHLE:

A RESOLUTION OF THE NORTHERN CHEYENNE TRIBAL COUNCIL APPROVING A CONTRACT WITH SMILES ACROSS MONTANA (SAM) TO PROVIDE SCHOOL BASED DENTAL SERVICES TO THE NORTHERN CHEYENNE NATION

WHEREAS, an amendment to the current Indian Health Service Annual Funding Agreement has been approved expanding the Tribal Board of Health's services to include comprehensive, high quality healthcare to the people of the Northern Cheyenne Nation in school settings, and

WHEREAS, the Tribal Board of Health's school-based services will include dental care and screening to assure optimal health of the people of the Northern Cheyenne Nation, and

WHEREAS, Smiles Across Montana or "SAM" currently partners with the Northern Cheyenne Head Start Program, Lame Deer Public Schools, and the Northern Cheyenne Tribal School to provide students access to basic dental screenings, and

WHEREAS, Smiles Across Montana is a non-profit organization certified by the State of Montana and which complies with all federal and state regulations governing such organizations, and

WHEREAS, pursuant to the Northern Cheyenne Tribe's Financial Policies, Section 1 (A) (3), Competition, Non-competitive Procurement, the Northern Cheyenne Tribal President is empowered to approve a contract when a sole source award is permissible under the funding agency for non-competitive proposals; and, under Section 5(b) Procurement by Non-Competitive, contracts over \$100,000.00 must be approved with the signature of the Northern Cheyenne Tribal President, and

WHEREAS, pursuant to the Northern Cheyenne Tribe's Plan of Operations, Finance Policies on Sole Source, the Northern Cheyenne Tribal Council hereby approves a sole-source contract with Smiles Across Montana to compensate the organization for providing school-based dental services as outlined in the attached proposal, "Smiles Across Montana Proposal for a School Based Clinic With Northern Cheyenne Tribe", to which a proposal and contract is attached and incorporated into this resolution by reference, and

WHEREAS, contract payments shall be made based on invoices by the contractor sent to the Tribal Health Director, who shall ensure payment (from Tribal Health funds) is made after inspection of work is completed, and

WHEREAS, the Northern Cheyenne Tribal Council further recognizes that for this project, time is of the essence and the sole source is allowable and supported by Northern Cheyenne Tribal Board of Health, and chooses to sole-source professional services for this scope of work as the provider is uniquely qualified and situated to provide these services to the Northern Cheyenne Tribe, and

WHEREAS, The Northern Cheyenne Tribal Council, has determined that based upon Smiles Across Montana's proposal to partner in providing care, the agreement with Smiles Across Montana is fair and reasonable, and

WHEREAS, the Northern Cheyenne Tribal Council desires to approve the Community and School-based Dental Services Contract with Smiles Across Montana.

NOW THEREFORE BE IT RESOLVED THAT, that the Northern Cheyenne Tribal Council approves a sole source contract with Smiles Across Montana for community and school-based dental services; and

BE IT FURTHER RESOLVED THAT, the Northern Cheyenne Tribal Council hereby designates the Tribal Health Director to administer this contract.

DISCUSSION: ITEM #10 - PRODUCE PRESCRIPTION PILOT PROGRAM

CURTIS ELKSHOULDER, JR.:

A RESOLUTION OF THE NORTHERN CHEYENNE TRIBAL COUNCIL AUTHORIZING THE NORTHERN CHEYENNE TRIBAL BOARD OF HEALTH TO SUBMIT AN APPLICATION FOR THE PRODUCE PRESCRIPTION PILOT PROGRAM (P4) FROM THE DEPARTMENT OF HEALTH AND HUMAN SERVICES INDIAN HEALTH SERVICE UNDER FUNDING OPPORTUNITY NUMBER HHS-2023-HIS-PPPP-0001.

WHEREAS, the Produce Prescription Pilot Program (P4) is a federally funded Cooperative Agreement program by the United States Department of Health and Human Services (Indian Health Services) which will provide an opportunity to engage Tribal communities in addressing food insecurity and decreasing the risk for diet related illnesses; and

WHEREAS, the Northern Cheyenne Tribal Board of Health desires to accomplish the goals of this Produce Prescription Pilot Program by implementing the following objectives: 1.) Reduce food insecurity, 2.) Improve overall dietary health by increasing fruit, vegetables, and traditional food consumption. 3.) Improve healthcare outcomes for Type II diabetics and individuals with a Body Mass Index (BMI) of 30 or greater.

THEREFORE BE IT RESOLVED, that the Northern Cheyenne Tribe hereby authorizes the Northern Cheyenne Tribal Board of Health to submit an application for the Produce Prescription Pilot Program from the Department of Health and Human Services in the amount of \$500,000.00 per year for 5 years to increase access to fresh fruits, vegetables and traditional foods, reduce food insecurity and improve health care outcomes for Type 2 Diabetics and Individuals with a Body Mass Index (BMI) of 30 or Greater on the Northern Cheyenne Reservation.

BE IT FINALLY RESOLVED, that the Northern Cheyenne Tribe agrees to sign the required documentation required for the grant application and to receive manage and oversee the grant funds.

COUNCILWOMAN LITTLE EAGLE:

A RESOLUTION OF THE NORTHERN CHEYENNE TRIBAL COUNCIL DESIGNATING JUNE AS PRIDE MONTH

WHEREAS, the LGBTQ2S+ community (which means lesbian, gay, bisexual, transgender, queer/questioning, Two-Spirit, and the "+" acknowledges other identities that are not included) has suffered from many forms of mistreatment;

WHEREAS, the LGBTQ2S+ community includes Two-spirit (also known as two spirit, 2S, or twospirited), which is an umbrella term for Native people who have both male and female spirits and acknowledges different gender identities present among Native people of North America;

WHEREAS, the Cheyenne language includes a specific term for Two-spirit persons, which is *Neše 'evootsetane*, meaning half man, half woman;

WHEREAS, while there has been remarkable progress towards acceptance and equality, members of the LGBTQ2S+ community continue to face discrimination, intolerance, and hate;

WHEREAS, LGBTQ2S+ individuals, in particular our youth, when compared to their peers are far more likely to experience violence and bullying at school; to suffer from depression; to struggle with substance use; and to have attempted suicide;

WHEREAS, many tribal and non-tribal governments and organizations have recognized June as Pride Month, for the purposes of honoring the movement for LGBTQ2S+ rights and celebrating LGBTQ2S+ culture;

WHEREAS, to recognize the historical challenges of the LGBTQ2S+ and Two-spirit community, to strongly support and promote the rights of the LGBTQ2S+ and the Two-spirit community, to strongly encourage all members and especially the youth to positively self-identify, and to celebrate the LGBTQ2S+ and Two-spirit culture, the Tribal Council wishes to formally recognize

June of each year as LGBTQ2S+ Pride Month (or simply "Pride Month") on the Northern Cheyenne Reservation;

WHEREAS, by formally recognizing June as Pride Month, the Tribal Council joins forces with many other tribal and non-tribal governments and organizations across the United States and the world that officially support the rights of the LGBTQ2S+ community; and

WHEREAS, by formally recognizing June as Pride Month, the Tribal Council intends to foster the just, fair, equal treatment and unlimited acceptance of the LGBTQ2S+ community on and off the Reservation each June and throughout each year; now

THEREFORE, BE IT RESOLVED that the Northern Cheyenne Tribe hereby designates and supports the month of June each year as Pride Month on the Northern Cheyenne Reservation;

BE IT FURTHER RESOLVED, the Northern Cheyenne Tribe affirms its support for LGBTQ2S+ persons among our membership and stands with them to protect their civil rights and their ability to live openly and without fear;

AND BE IT FINALLY RESOLVED that the Northern Cheyenne Tribe urges all members,

residents and visitors to build a culture of inclusiveness and acceptance, promote positive self-identity among the youth, and support Two-spirit people – during this month and every month.

DISCUSSION: ITEM #16 - CLIMATE POLLUTION REDUCTION PROGRAM GRANT

COUNCILWOMAN LITTLE EAGLE:

A RESOLUTION OF THE NORTHERN CHEYENNE TRIBAL COUNCIL AUTHORIZING SUBMISSION OF A PROPOSAL TO THE U.S. ENVIRONMENTAL PROTECTION AGENCY FOR A CLIMATE POLLUTION REDUCTION PROGRAM GRANT

WHEREAS, the U.S. Environmental Protection Agency (EPA) is administering a program under the Inflation Reduction Act of 2022 (IRA) call the "Climate Pollution Reduction

Grant" (CPRG), program which provides federal funding for governmental organizations, including tribes, to empower them to take climate action;

WHEREAS, the purpose of the CPRG program is to provide funding to address climate pollution and deliver clean energy, which dovetails with the Tribe's goals of protecting the natural world, reducing the impacts of climate change, and pursuing sustainable energy opportunities;

WHEREAS, in awarding the grant, EPA must ensure that no less than 40% of the benefits of the program are delivered to economically disadvantaged communities, such as the Northern Cheyenne Tribal community, and to facilitate pollution reduction plans that will provide new workforce training and address environmental injustices in those communities;

WHEREAS, the CPRG program has two distinct but related phases:

planning grants: \$250 million for eligible entities to develop plans to reduce climate pollution, of which EPA has set aside \$25 million for federally recognized Tribes and Tribal consortia; and

implementation grants: \$4.6075 billion for grants to implement measures from the pollution reduction plans developed with planning grant funding.

WHEREAS, obtaining a planning grant is a prerequisite to obtaining an implementation grant;

WHEREAS, the CPRG planning grant, is a noncompetitive grant, provides tribes up to \$500,000, and requires no matching funds; WHEREAS, the funding would allow the Tribe to hire staff and consultants to bolster its administrative capacity and tools to carry out climate initiatives, facilitate community engagement and Tribal member input, and put the Tribe in a position to obtain the much larger CPRG implementation grant; and

WHEREAS, the Tribal Council wishes to submit a CPRG grant application to create a climate pollution action plan with the further intent to implement the plan once it is created and pursue additional grant funds to assist therewith; now

THEREFORE, BE IT RESOLVED that the Tribal Council approves and authorizes the submission of a CPRG grant application to EPA on behalf of the Triba and approves, authorizes and instructs the Tribal President to work with the Tribal staff and attorneys to sign and submit the proposal on behalf of the Tribe and take all actions necessary to implement this Resolution.
