Donna Fisher: And if there is an outbreak, we need it addressed immediately.

Donna Fisher: "Reported." It wasn't reported to our office, so an anonymous person reported the outbreak there at head start. So, we had to take action from my office.

Roberta Harris: So, if you do remember, I did call and did report that one to you and we had to do a close down because we did have a positive. So that was documented.

Donna Fisher: Yeah, that was the one. But the one that had three, that was the last time we sprayed. Someone called and told us there were some positive cases there.

Roberta Harris: Okay, so we did close down for the 14 days and we did follow and call public health and went through and didn't receive back any reports of any positives that were related to...

Donna Fisher: That was from the individual that was sent to the hospital.

Roberta Harris: Okay. I will continue to go ahead and follow our reopening plans and to continue to report any positives to public health.

Lane Spotted Elk: I have a comment. The vaccine from ages 6 to 11, that was Moderna. But the Pfizer is still 5 to 11.

Donna Fisher: But these are three and four-year-olds right?

Roberta Harris: Yes, three-, four-, and five-year-olds.

Phillip Beckman: Studies are showing that Moderna is much more effective than Pfizer in five-year-olds.

Lane Spotted Elk: And then the last whereas, it ends with the governor's office. I think we should keep it within the tribe, you know? We have our own laws here.

Donna Fisher: Yeah, strike it. And he doesn't have any policies right now.

Three-year-olds, we have no more than 17 children enrolled in any class. The more than 15 children enrolled in any double session class. Under three-year-olds, no more than eight or nine

children enrolled in any class. Depending on the number of teachers. Right now, we have two teachers per class.

Debra Charette: How many centers are open?

Roberta Harris: Five. And by open I mean virtual, online.

Phillip Beckman: Does that seem to be working out for the kids?

Roberta Harris: So far it's been a bit of a challenge. We were on travel when we got the executive orders and we had to come back to the center, bring everybody together, and start getting ready for virtual. It did take a little bit of time, we are in our third or fourth week right now. Some of the teachers that are very familiar with technology had to come on board and help do some trading with us.

Debra Charette: Have you done your surveys of who needs Internet yet?

Roberta Harris: I just had that information this morning, so I'll be able to provide you with a better number.

Diane Spotted Elk: And they all have devices that they...?

Roberta Harris: Right now they're using electronic that curriculum, so they are given a number. The teachers provide that number to the parent, so when the parent logs on, they put in the number, and are able to track everything that they're doing.

Eva Foote: I have a question. The five, is that including Ashland?

Roberta Harris: We do have a few coming from Ashland, yes.

Melissa Fisher: There is no center for Ashland.

Roberta Harris: Yes, were going to present a resolution to close the Kids At Work, but we are still serving kids from Ashland and providing them with an opportunity to come to one of the center is in Lame Deer or Busby.

Phillip Beckman: So, moving forward, what are the plans to establish a center in Ashland?

Roberta Harris: In order to establish another center in Ashland, right now just because we are under enrolled and that's why we closed. At that time, history has shown with children who are starting there, there's an advocate for children. We are also competing against the other Preschool.

Donna Fisher: I don't think it's open.

Roberta Harris: Businesswise, as far as having a full-time teacher, assistant full-time teacher, and a cook, it was a big budget. So, it came down to funding.

Melissa Fisher: So in this fifth whereas, did you have public hearings? Or how did you get your information from the communities?

Rodney Trahan: We posted it, as normally like we do. In the post offices, wherever we post our normal job applications, and the admin building here. At our offices, and in the community.

Melissa Fisher: And you got a lot of feedback from it?

Rodney Trahan: We rarely get a lot of feedback from it, so we get what we can take.

Melissa Fisher: So, you don't have public town hall meetings where people attend and voice their concerns?

Rodney Trahan: We usually have those with IHP. Indian Housing Plan. In the summertime, we'll do the gatherings and community cleanup and give people the opportunity to fill out the comments form and get feedback that way. So, we can rely on that as well, and we did do that this year in August. We also tallied those on a website, we sent those out, all of you got one of those surveys. And tallied those results on our database.

Henry Speelman: I make the motion for Northern Cheyenne Housing Authority to put in for this ICDBG-ARP Grant.

Diane Spotted Elk: So, I have a question. So, this would not only cover the low rent units, but also any home, private—?

Rodney Trahan: We're hoping to be able to cover any houses on the reservation that apply. I think the board will sit down and develop a budget. The max benefit I guess you would call it, that way we're not unfairly burdening or having some people literally use up all of the grant funds. We want to make it as equitable as possible.

Diane Spotted Elk: And then my next question is, with the staffing that you already have to help with repairs to the unit that you already have, are you expanding your employees, your laborers, your skilled workers?

Rodney Trahan: It will be a combination of our workers and contractors. There are number of things that our staff are not qualified or capable of doing, so we have to outsource that.

Rodney Trahan: Thank you.

Melissa Fisher: One more question—what is the amount spent on your ERAP?

Rodney Trahan: We're just over \$1 million right now.

Melissa Fisher: About 3 weeks ago, you told me that same amount. So, you're not moving applications fast enough, or why is it that same amount?

Rodney Trahan: Well, right now we're processing as fast as we can with the staff that we have.

Melissa Fisher: So, did you hire new staff?

Rodney Trahan: We got applications out. We had three staff this week, not for ERAP, but was for our occupancy.

Melissa Fisher: So, it's still over \$1 million?

Rodney Trahan: It's \$1.2 million.

Donna Fisher: So, what's the balance? How much do you have left?

Rodney Trahan: \$3.2 million was allocated, and we knew we were never going to spend that whole amount.

Donna Fisher: How did you figure that?

Rodney Trahan: We didn't figure that, the Treasury did, they allocated it. They did a formula based on however much was in the big pot and sent it our way. And then we got notification it was in our account.

Donna Fisher: You haven't hired any staff for ERAP?

Rodney Trahan: We did. Unfortunately, they couldn't...we had to terminate them for just leaving, basically walking away.

Donna Fisher: Did you not try to fulfill those positions?

Rodney Trahan: Oh, we did.

Donna Fisher: So how many staff members do you have, not housing staff members, but ERAP staff members?

Rodney Trahan: So what we've done is taken the current accounts payable staff and our accounting and finance, and reapportioned them to handle ERAP applications until we get more applications in for those positions.

Donna Fisher: Well, you only have how many more days to spend the money?

Rodney Trahan: The deadline was actually September 30<sup>th</sup>, but due to some complications in Treasury and what they were trying to do, they extended that. There's not a definite date, so we are taking applications and processing them as we can. But if we get in and they get in the system, they will get processed and we will pay those out, assuming that they are approved and they meet eligibility requirements.

Donna Fisher: So, how many applications do you process per week?

Rodney Trahan: I'm not sure. It does take a screening, it takes a while, especially if they're out of state. Having to make sure they meet the average median income requirements. Making sure they have the documentation from their landlord. Sometimes the ROI isn't included, so we have to chase them down for that, so we can get their utility bills so we don't pay the wrong bill. Administratively, it takes a lot of work. I don't know how many we do on a weekly basis because our current staff is having to make sure we keep up with our normal AP as well, so they are working overtime, usually evenings and weekends and doing their best to catch up.

Melissa Fisher: Okay, I'd like to go into Executive Session with Rodney on a couple other requests that we have.

A RESOLUTION OF THE NORTHERN CHEYENNE TRIBAL COUNCIL APPROVING THE LOW-INCOME HOME ENERGY ASSISTANCE PROGRAM FOR FISCAL YEAR 2022

Lane Spotted Elk: Is there an amount on there that we're applying for?

Letha Whitewolf: The budget for this year? We apply for the budget that was approved the previous year, because when we get our Award Letter, then I do the budget.

Debra Charette: Okay, how much was your award last year, then?

Melissa Fisher: Is it the 347A? Or any of those ones?

Letha Whitewolf: It's either 347 or 345A, it's Admin. And then, it's like \$52,677.

Melissa Fisher: So, there was a budget passed for 347A for \$66,888.

Letha Whitewolf: That's the supplemental budget. Separate from this.

Melissa Fisher: Okay, so that's 345.

Letha Whitewolf: Yeah, 345A is for \$52,677. And the direct cost budget is \$345-999. And that's how Lorna likes to leave it. That one is for \$486,000. Out of the Admin budget, I operate on 10% of the total budget--\$454,295.00

Lane Spotted Elk: I have a question. I know we stopped doing the wood vendors, but for a lot of people, they only have a wood stove. So, how are we going to accommodate those folks who require wood. Have we put any thought into assisting those individuals, out of our LIHEAP funding?

Letha Whitewolf: I didn't do wood this year.

Lane Spotted Elk: I mean, we could always modify it, if that's what the Council wants to do.

Letha Whitewolf: Yeah, if that's what you want to do.

Diane Spotted Elk: I do agree that a lot of our people use wood and not only as their first heating source, but when they're getting low on their prepaid, they start using their wood. Not everybody has a pickup or chainsaws.

Lane Spotted Elk: And I think that was a problem before, identifying enough vendors or a vendor that could fulfill the total amount.

Melissa Fisher: Yeah, what was your issue with vendors before?

Letha Whitewolf: It became a problem where they weren't getting their wood, and they weren't getting enough.

Melissa Fisher: So, they were getting paid for a full cord, but they weren't getting a full cord.

Letha Whitewolf: Yeah.

Melissa Fisher: And so, the wood vendors weren't being honest with their deliveries, but still getting the full amount.

Letha Whitewolf: Yeah, some of them were, yeah. I don't have the staff to go out there and check on this stuff. I have two staff, that's me and my secretary.

Lane Spotted Elk: I think since the Tribe has a very successful Day Labor program now, maybe instead of doing Day Labor in the spring and summer, if we expanded it into the winter and fall. Have them be responsible for monitoring.

Melissa Fisher: What about forestry?

Lane Spotted Elk: They're federally funded, too, I don't know.

Melissa Fisher: The liability for Day Labor is running chainsaws. The insurance, are we going to pay?

Lane Spotted Elk: I think so, we pay for a Volunteer Clause under our insurance already. Just as an option, because, to get younger people to contribute. I've gotten a lot of requests from people for wood, and we get this funding every year to help with heat assistance. And a big part of how people live now is off wood. So, that's why I wanted to bring up the issue and see how everybody feels about that.

Council continued to discuss how to secure wood vending.

Lane Spotted Elk: So, I guess that would mean we amend the application to include wood vending. I mean, we only do this application once a year. I think we have the capacity to figure this out and make it work. Make sure that we put wood vending in there. And we'll help facilitate this, and the CARES act has added another staff member for you. So, we can figure out the resources for what you need.

Serena Wetherelt: I don't think she does.

Diane Spotted Elk: I know they give her a really hard time, there's days that she cries.

Donna Fisher: Who, the Board gives her a hard time?

Diane Spotted Elk: Yes.

Donna Fisher: Well, hopefully this one will work out for her.

### A RESOLUTION OF THE NORTHERN CHEYENNE TRIBAL COUNCIL APPOINTING RANGE / GRAZING COMMITTEE MEMBERS

Norma Gourneau: I have a question, Donna. Just for clarification, in the contract proposal it said that the Chairman of the Land Authority was going to be the Supervisor. Has that been corrected and changed?

Melissa Fisher: When Renee was President, there was a resolution passed that the Board Chair was the Supervisor over the Director of Land Authority.

Donna Fisher: Oh yeah, that's been changed.

Norma Gourneau: There's been an official mod on the contract?

Donna Fisher: Yes, we've worked through it. In fact, we've done our first report for our review. We had 71 compliance reports that were not done the past couple of years. So, we were able to do 25 and we're working on them. We're under our review, we put our first report into the federal court last week.

Norma Gourneau: I guess my question is, has that section been taken out of the contract, and there's been a mod for them?

Donna Fisher: Yes. I'm pretty sure it has because we did a new organizational chart.

Debra Charette: And we have questions, too, if there were more landowners being considered for this.

Donna Fisher: I think everybody's a landowner. The entire tribal membership is a landowner.

Debra Charette: Yeah, but individual landowners.

Donna Fisher: Yeah, well, every tribal member is a landowner. We're not splitting them. There's allot fees and tribal membership, everybody who is a tribal member owns land.

Lane Spotted Elk: So, what is the term on these?

Donna Fisher: It says concurrent with the Presidency.

Lane Spotted Elk: Okay. And how many are landowners?

Donna Fisher: All of them. We're all landowners.

Diane Spotted Elk: The question would be, how many are operators and what information are they privy to, in terms of competitiveness in um...

Lane Spotted Elk: I think there's a Code of Ethics.

Diane Spotted Elk: But you have to trust the people that you're appointing, but we don't always know that.

Donna Fisher: But they're not in the database. They're not getting in the database. They're just going to be passing things on the board.

Diane Spotted Elk: TAMS is only privileged to those who have background checks. But, that information can easily be given to those.

Donna Fisher: And then you could be in trouble if you violate that.

Phillip Beckman: Same thing here, information could be passed from finance pretty easily.

Diane Spotted Elk: And it has.

Donna Fisher: And these guys are only going to be dealing with grazing issues on the board.

Melissa Fisher: And the very last Director of Land Authority was taking information out of TAMS and sharing that information.

Diane Spotted Elk: So, who's to say that is not going to happen again. That's the question.

Donna Fisher: It's got to be guarded. You've got to have ethics.

Eva Foote: So, this grazing board cannot sit on any other boards, or...committees or stuff like that?

Donna Fisher: This is just the range board. Grazing/range board. They'll just allocate grass and do whatever they need to do with the budget. That's basically what they'll be doing.
