## A RESOLUTION MAKING A PERMANENT CHANGE TO THE PERSONNEL MANUAL GRANTING ADDITIONAL CARRYOVER LEAVE DUE TO THE COVID-19 PANDEMIC

Lane Spotted Elk: Therefore, be it resolved that the Tribal Council hereby reinstates up to 60 hours of leave for accrued leave hours lost for fiscal year 2020 only, up to maximum hours of 160, 210, or 260 hours, respectively.

Debra Charette: Wait, it's 140...

Lane Spotted Elk: It's 140, 190, and 240 respectively, depending on the years of consecutive employment. Also, making this a permanent amendment to the personnel policy. So, it would be going forward. Finally, be it resolved the Tribal Council hereby approves a leave payout to essential employees who lost leave beyond the previously mentioned 60 hours of reinstated leave. The leave payout is to be appropriated from the CARES ACT funding due to their inability to take leave in FY2020. This is a follow-up resolution from the previous meeting because the previous resolution didn't make it a permanent amendment. So, I had requested that the President not sign the previous one that was passed because it only would've affected 2020, but this one would actually make a permanent amendment going forward. So, it would increase those thresholds by 40 hours. Up to 2 years of service, 140 hours; 2-6 years, 190 hours; and over 6 years, 240 hours.

Debra Charette: On your last Whereas, the 60 should go to 40?

Lane Spotted Elk: Yep, 60 should go to 40. So, everything should be increased by 40. So, essentially the employees will be reinstated up to 40 hours, and any additional leave because of their essential status. And a big part of the response for the Tribe's pandemic response, would essentially be eligible for a leave payout as well. Therefore, it would make the employees, so they would either get a portion of it credited back to their leave bank and they would get paid out the difference. In essence, our employees would not be losing anything.

Donna Fisher: Do we have a number? Of how many employees?

Lane Spotted Elk: Yeah, HR said she would be right back, and she developed a spreadsheet. There she is. She calculated that out if we were to do that, so.

#### Denise Swank entered session @ 10:20 am.

Denise Swank: What it came down to is that once we changed the status of the additional 40 hours onto what they have existing, it will come out to about \$87,000. Give or take a few more.

Donna Fisher: How many employees?

Denise Swank: Oh geez, I didn't count the employees, we have quite a few. This is all of them. And it's one sheet per employee. And they range from 5 ½ hours, so the person with 5 ½ hours that they lost, they won't get a payout because their hours are going to be increased that carryover. But we did have one employee that had 280 hours, and one that had almost 100 hours that they lost. So, that person will get 40 hours taken from that and added to the one they can carry over, and they will get paid for 360 hours. Their payout will be for 360 instead of 400 hours.

Lane Spotted Elk: And primarily, one of the largest departments is the Board of Health?

Denise Swank: Yeah.

Lane Spotted Elk: Yeah. And I know the employees really appreciate the Tribe doing this.

Denise Swank: Board of Health, and we have Finance.

A RESOLUTION AUTHORIZING AND APPROVING THE NORTHERN CHEYENNE TRIBAL BOARD OF HEALTH TO CONTRACT WITH THE INDIAN HEALTH SERVICE UNDER THE INDIAN SELF-DETERMINATION AND EDUCATION ASSISTANCE ACT FOR THE TRIBE'S PUBLIC HEALTH NURSING PROGRAM AND ASSOCIATED FUNDING

Mena Limpy: Good morning, everyone. So, myself and President Fisher and our Attorney have been working on plans for contracting the PHN program. I'm here today to present the resolution to get back our PHN program, so that it's tribally-run. (Mena Limpy reads the Resolution). Does anybody have any questions on it?

Silver Little Eagle: Is there a pool of nurses ready for the PHN program?

Mena Limpy: No, but we would advertise. There are some nurses in our THIP program that would be interested. I can tell you when IHS did take over, there was, at the time, 6 nurses and 1 LPN and 1 Administrative Secretary.

Silver Little Eagle: So, last time we gave the nursing program to IHS, was because of the pandemic? Or, what was the history as to why we let go of the PHN?

Lane Spotted Elk: I think this could warrant an internal discussion, just because there was litigation involved. So, the Tribe had to litigate to work to where we are now. But right now, I guess, requesting this contract back is within the Tribe's right. There were other circumstances, but I guess that would take more discussion. And probably have the Attorneys present to talk

about it. But there was a lengthy issue that happened, but this is a good step today, that the Tribe is going to ask for this back. And operate it, and we have the qualified individuals here, Tribal members too, who could operate this program. And I know on staff, we have how many nurses?

Mena Limpy: Four.

Lane Spotted Elk: We have four registered nurses, and I think this would be a good step in exercising our self-determination.
