Lane Spotted Elk: Just real quick about the five on committee. I wonder if we can align it to some of our other committees where it's 4 plus the Chair.

Donna Fisher: A majority vote of committee?

Lane Spotted Elk: Yeah, under Quorum it says five committee members constitute a quorum. But the five is including the Chair, right?

Donna Fisher: Mm-hmm. So, the Chair will make quorum. But they're not allowed to vote.

Lane Spotted Elk: To be four committee members and then one Chair. Just so we can...

Donna Fisher: Yeah, so as we go, we can always end this. And under the second bullet of restrictions on the Land Authority, it used to be even if you couldn't get it, you were able to pass a resolution from the Council if you did have permits or anything that it was okay. But it was by resolution, just so there isn't a conflict of interest. So, if you want to put that in there. Or, by resolution.

Debra Charette: Also, I agree with Lane, if you lower that quorum. What he's saying. Only because this is our council committee and if that's what we want, then we should be able to go ahead and do that.

Donna Fisher: Yeah, you guys can fix it and, but you need to amend it as you go.

Melissa Fisher: But five would be right because you have ten council members. Any five would make a quorum.

Phillip Beckman: It's unspoken and understood that the five committee members includes the Chairman. We've done that in other meetings as well.

Lane Spotted Elk: So, maybe after it says, "quorum at any meeting, including the Chairman/Chairwoman." I think that could be an amendment we could make here.

Debra Charette: Yeah, that would work.

Phillip Beckman: Right after "five committee members," inject it right there, "including Vice or Chairman."

Serena Wetherelt: Well, actually, it's not really going to be a quorum because he doesn't vote and there's only going to be four.

Donna Fisher: But five makes a quorum. And if you're in a meeting, and that's half. Half of them. You're still just like this. I don't vote, but I still make the quorum.

Melissa Fisher: And that's the same way with Budget Finance. Five makes a quorum. The Chair doesn't vote.

Phillip Beckman: Unless there's a tie that needs to be broke.

Donna Fisher: If it needs to be amended or whatever, you guys can amend it. Whatever to fit your—

A RESOLUTION OF THE NORTHERN CHEYENNE TRIBAL COUNCIL ACCEPTING THE REORGANIZATION OF THE TRIBAL AGRICULTURE PROGRAM, A P.L. 93-638 CONTRACT, AND THE LAND AUTHORITY

Diane Spotted Elk: So, with separation, there will be separate personnel.

Donna Fisher: Yes. So, these positions are already ready to be advertised for the Ag program. So, this is taking that so we can reflect these in the budget, so that will separate the budgets.

Ryhal Rowland: And the land is responsible for their own, right?

Donna Fisher: Yeah, the Land Committee will have a separate budget. We're just pulling the range program apart, away from the Land Committee, basically. It will be a stand alone 638 program. And it's already heading in a good direction. We should have permits done next week and get everything back on track.

Debra Charette: How many jobs are you advertising?

Donna Fisher: We're advertising four jobs. We reorganized to a Range Manager, a Range Tech, and two seasonal positions.

Debra Charette: Don't they already have range techs down there?

Donna Fisher: Yeah, we do.

Debra Charette: So, they will just move over?

Donna Fisher: They will reapply for their positions. And they'll be seasonal.

Debra Charette: And did that budget already come forward? Sorry, I'm coming in kind of late.

Donna Fisher: These resolutions will help us split the budget. The budgets will be reflected at the next Budget Finance meeting.

Melissa Fisher: Diane just asked her to rename the positions again.

Lane Spotted Elk: Would it be possible for the Council to receive organizational charts that will be developed, that way there will be clear lines of authority between Land Authority and how it interacts with the Range Program. I know this resolution will separate them, but there's still needing to be some working relationship between the two. That way, we can see those clear lines of supervision. And how the Grazing Board interacts and the Land Committee interacts with the staff.

A RESOLUTION AUTHORIZING THE FORMATION OF THE NORTHERN CHEYENNE MODULAR BUSINESS FOR THE NORTHERN CHEYENNE TRIBE. THE NORTHERN CHEYENNE ECONOMIC DEVELOPMENT DEPARTMENT WILL BEGIN THE PROCESS OF ENTERING INTO A BUSINESS RELATIONSHIP WITH FACTORY BUILT PARTNERS 1, LLC, TO DEVELOP A MODULAR

MANUFACTURING BUSINESS LOCATED ON THE NORTHERN CHEYENNE RESERVATION

Wayne Hohs: We're honored to be here today. We often get a lot of opportunities to partner with the tribes that we represent. That's one of my primary responsibilities is to do due diligence, research these potential project opportunities and identify those that we think would be a good business opportunity for the tribes that we represent. Including the Northern Cheyenne. In December, I had the privilege of meeting with the Senior Representatives from the Black Diamond Group and their American subsidiary box modular in Texas. They do a lot of work with First Nations in Canada and are looking for an opportunity to start working with tribes in the lower 48 (states). I took him on a visit, meeting with some of the tribes in Montana, including Melissa and Fonda and some others here with the Northern Cheyenne. Based on that assessment, I felt that this Tribe was probably the best fit for several reasons. Subsequent to that, several of your council members, including Lane, Melissa, Diane, along with Fonda and Sheldon King, traveled to Alabama. This is a tremendous business opportunity.

Wayne Hohs continued his presentation on Atlantic Structures NA.

Sheldon King entered session @ 11:14 a.m.

Sheldon King: Good morning, Council. With this business coming upon our Tribe, we're also looking for other ways of employing our tribal members. Because the plants are getting ready to close. When you look at it, you see everything out there with the price of lumber, it's outrageous. We're looking for other ways to build our building, we're looking at building a community center here, a food bank. When we went to look at this in Alabama, they were producing these panels within minutes. It takes away from having to buy the high price lumber. It prevents cockroaches, bed bugs, and it seals out—it's good for the power. The heating and cooling, too. With this resolution, it's always that the tribe comes first. So, we always take it to look for legal advice, because we don't want to lead you down the wrong road. And it's for the betterment of our people. We could start with our elders that have safe homes there. And downsizing their own homes. And letting them live in a safe environment. And it comes back to our tribal members that go off the reservation, and when they come home, it's really hard to find somewhere to live. And you go to housing, and it's for low-income. We end up living with our relatives. You want to see economic development downtown. And when you go to Billings, you see all these new storefronts going up, with a fraction of the cost.

Debra Charette exited session via teleconference @ 11:18 a.m.

Phillip Beckman: This is so interesting. I was looking at videos to research it, but I want to commend you. I know Sheldon had mentioned this a while back and I was pretty excited and motivated by it. And now, to see this coming about, this is a game changer. It's exciting to see this. So, I commend you all for this—Sheldon, Melissa, Diane. All of you that went down there to check this out.

Sheldon King: And this comes back to our contractors. Our contractors here are going to learn how to utilize these, and see how easy it is for them to go up. When you go to the south side of

Billings, they have a subdivision out there. And houses are being built within 3-4 weeks. And these storefronts, they can use that, too.

Donna Fisher: The Tribe is also hiring a Project Manager, and they'll be involved with all of the buildings and plans. So that the Tribe doesn't get ripped off, that it's built right. The Project Manager should be on in a couple of weeks. So, all the layout plans would have to be reviewed by the Project Manager. And let's get started on the Dialysis Center.

DOI-128 (1996), DESIRES TO CHANGE THIS APPROVAL AND RECOGNITION TO BE IN ORDINANCE FORM

Andy Elkshoulder: Pevawona'ae. I'm here before you, there was a resolution before this ordinance. I'm on the Cheyenne coalition here at Dull Knife. Several meetings, we've been talking about this particular ordinance. The thing we're trying to see is change this resolution into an ordinance so it has more teeth to it. We're at the point where we don't have that many

Cheyenne speakers. Some of those have gone on because of their age, medical reasons, and stuff like that. We're at the point that we're kind of in a panic mode to make sure we pass something like this. We represent the different schools here, just not Busby school yet. A lot of times we encounter in schools is that they make Cheyenne language an elective. I also announced this on KIKC a week and a half ago.

Andy Elkshoulder and fellow presenters continued discussion of need for this Ordinance.

Lane Spotted Elk: Madame Chair, I would like to propose that we make an amendment to this Ordinance. Under "therefore be it resolved," that the Northern Cheyenne Council reaffirm its support it will contribute available financial resources to the coalition.

Diane Spotted Elk: This one is under Chief Dull Knife College. The one I'll be presenting is community, grassroots.

Lane Spotted Elk: But we could support both financially.

Donna Fisher: We already do. They get the language grant from the state of Montana. There's a lot of money out there for it. That's why we've been getting together all the past resolutions that have been passed and were making sure that we put just one together. So you guys are established from the college and then we can spread the wealth.

Rhoda Bullcoming: We're a separate thing from Dull Knife. We don't get no funding.

Donna Fisher: Oh, but you're part of Dull Knife?

Lane Spotted Elk: That's why I want to set up the framework for it, we're not putting a dollar amount to it. But we can personally fund some of their requests that come in. That's the intent of this.

Adeline Fox: Yeah, we don't want to be connected to Dull Knife.

Diane Spotted Elk: On the outside looking in, it looks like that. Simply because you have your meetings there.

A RESOLUTION OF THE NORTHERN CHEYENNE TRIBAL COUNCIL TO APPROVE SUPPORT FOR A FULL PROPOSAL "TONGUE RIVER 2100 – FUTURE TONGUE RIVER STREAMFLOW ESTIMATES TO ENABLE NORTHERN CHEYENNE DATADRIVEN WATER MANAGEMENT AND PLANNING" FOR THE NORTHERN CHEYENNE NATURAL RESOURCES DEPARTMENT

Jason Whiteman, Sr.: This is a pre-proposal submitted to the United States Geological Survey and Central office. The purpose is—well, it's a pre-proposal that was approved for allowing it to be submitted as a full proposal. And this is a resolution of support and this would focus on the Northern Cheyenne Tribe and at least four principles. Investigator, collaborator, etc. The first is Theo Barnhart, and he's with USGS in Helena, then myself as a co-investigator, collaborator will be Shanny Spang Gion, and the other gentleman. The focus will be on future water development and it's called Tongue River model. We have an older Tongue River model, which is not recommended, so then we're updating that model now. It will also help us in future water management, especially in the reservoir and even for water marketing. So, those are the few areas the stakeholders—well, first of all, Tongue River and the Bighorn Mountains and parts of Wyoming that it comes down into Montana. It eventually leaves near Miles City. So, that's the Tongue River basin watershed. It will incorporate everything in there. And the watershed, all the elements in there. The stakeholders will include Wyoming water users, Tongue River Water Association, of course the Northern Cheyenne Tribe, and Tongue River Reservoir, which is DNRC. Those are some of the stakeholders in this proposal here. But again, mainly we'll be focusing on Northern Cheyenne Tribe for future water management. This model will tell us 2100, so it's in the future. Actually, a professional hydrologist will look at all of the water resource data and Tongue River, and then develop a model. So, that's what we're planning to do with this proposal here. Then we'll have a public meeting, whether it's here, Northern Cheyenne...in the future, that is. Maybe next year. Hopefully then, the pandemic will ease up a little bit to allow us to have full public community meetings here. That's kind of the main thing, and I'd like to request for your resolution support with this proposal, it's due in mid-July. Appreciate your timing here to submit this.
