SUMMARY OF WORK:

Performs cleaning duties in the operation of the Northern Cheyenne Tribe.

JOB CHARACTERISTICS:

Nature of Work: This position **performs** physical labor in cleaning, ensuring a clean and safe building. This position **requires** moderate physical activity and adherence to standards of safety in cleaning and the use of chemical compounds. Position **may require** work in adverse weather or in extreme temperatures.

Personal Contacts: Minimal contact with the public. Some contact with tribal employees.

Supervision Received: Janitorial Supervisor

Essential Functions: General building cleaning **requires** ability to: operate scrubbers, buffers, vacuum cleaners, mop, wax floors, and sanitizing.

AREAS OF ACCOUNTABILITY AND PERFORMANCE:

Sweeps, scrubs, mops, waxes and polishes floors. Dusts and polishes furniture, washes windows, cleans walls, woodwork and lavatories.

Empties trash receptacles, shampoos carpeted areas and cleans and straightens meeting and conference rooms. **Operates** scrubbers, buffers, vacuum cleaner and other cleaning tools and equipment.

Performs other related duties as required.

JOB REQUIREMENTS:

Knowledge: This position **requires** a working knowledge of cleaning equipment, supplies, and techniques.

Skills: This position **requires** skills in the operation of cleaning.

Abilities: This position requires the ability to perform moderate physical activity; be dependable; adhere to standards of safety and confidentiality; complete tasks in a competent and timely manner; work as part of a team; communicate effectively, orally and in writing; follow verbal and written instructions; establish effective working relationships with fellow employees, supervisors and the public.

JOB PERFORMANCE STANDARDS:

Evaluation of this position will be base primarily upon performance of the proceeding requirements and duties. Examples of job criteria include, but are not limited to the following:

- ✓ Performs assigned duties
- ✓ Assures that Northern Cheyenne Tribal buildings are kept clean and tidy
- ✓ Helps to maintain the safety and confidentiality of the premises
- ✓ Demonstrates physical stamina to perform duties
- ✓ Effectively operates and maintains equipment
- ✓ Adheres to practice of safety in working with cleaning fluids & equipment
- ✓ Deals tactfully and courteously with the public
- ✓ Observes work hours
- ✓ Demonstrates punctuality
- ✓ Establishes and maintains effective working relationships with fellow co-workers, employees, supervisors and the public.
- ✓ **Must** agree to and sign waiver for pre-employment drug testing.
- ✓ Indian Preference, with first preference given to qualified enrolled members of the Northern Cheyenne Tribe.

EDUCATION AND EXPERIENCE:

The above knowledge, skills and abilities are typically acquired through a combination of education and experience equivalent to:

- ✓ High School Diploma **preferred**, or G.E.D.

- ✓ Experience in building cleaning **preferred. (certificates are a plus)**
- ✓ **Must** have a valid Driver's License, and obtain a MT. Driving record
- ✓ **Must** clear a background check.
- ✓ **Must** submit to a Drug Test.
- ✓ **Must** be insurable.
