**BEAR BUTTE PROPERTY-WILLIE ROWLAND**

Tracy Robinson-I am an advocate for the development corporation. The Culture Commission has set up a meeting.

Vice President Russell-What about the societies that want to come?

Willie Rowland-Tell them to come.

Rachel Carroll-Bear Butte is very important to our people. It’s a very holy, sacred, place for many of our people. We need respect and love for the people and our land. Those two weeks during Sturgis, those who understand the bible, it’s like Sodom and Gomorra. You can have a policy not to allow things that deface the sacred property. I’m asking you to reconsider this, you have work that needs to be done here. Developments should be done with respect, and you should accept the recommendation from the Culture Commission.

Bilford Curley-When you buy something, you have to have a plan of how you’re going to pay for it. Thunderchild has been sitting there for four years. Maheo created that, when we are hurting, we go there to pray. The Culture Commission protects sacred sites. We had a meeting, I asked for transparency and communication. I didn’t get that. We went to forum and discussed a big bar that’s going to be built. We met with the Sioux, we’re trying to stop it from coming in. It’s our healing place, our home. We need to protect that. I want to see everyone work together rather than personal differences. We were left out, as far as recommending, we need to discuss this. Did you meet with the ceremonial sector? Have respect, plan and work together. Teanna and the archeologist are doing a great job.



Lafe Haugen-As my uncle Bilford shared, we were taught as Cheyenne to help each other. Donna Fisher picked up a hitchhiker that had been away from here for 30 years. All the buildings in town were vacant. He said "what happened?". She said, "politics happened". Cheyennes don't work together anymore. The Council has 4 year terms, all they did was fight. I asked to help any way I can. The campground has been vacant. There was a group of Christian bikers that used to rent the campground. We have property all around the Butte. The other property looks the rez right now, there are junk cars and garbage everywhere.

Tracy Robinson-Four years ago, I was part of the group that purchased that property. That mountain is very sacred to us. The issue was ensuring that the property stay preserved. Land Authority was supposed to come up with a plan. I also see the waste going on with what we have there. If we work together, we can solve those problems. Let's work on putting a solution together. I'm not a ceremonial man, but I do believe in our ways.

Vice President Russell-I want to thank the Council and the people for voting here. I was there at that time, I was Acting President. We asked for help over here and nothing was done on that. When I was up there, what I've gone through, people are very serious about that place. That's why I had that resolution. I'm not trying to keep that for myself. I go up there every time I need help. I hope we come up with a solution next week where we all agree on it.

Ernest Littlemouth-When I first went up there. I was one that agreed, I didn't look at the proposal they put in. I took an elder, we prayed up there, smoked a pipe. Some parents came and asked I knew about this. Did you hear about some kids getting drunk up there? I think we should leave it to the culture committees and societies to make that decision.

Sheldon King-My understanding was that it would be drug and alcohol free. Not to open a bar, not to allow drinking or drugs. I wish there was time for our elders to take our youth and show

how to do things right. For 4 years, it was deteriorating. We need to put a person in there that has respect for our land.

President Fisher-We bought the property to preserve and protect that mountain so people can worship there. We need to generate money so we can maintain it.

Meredith Tallbull-It takes money to do things. For the last 4 years, the only activity that it's had is CDKC, and Housing. We should have had a business plan, now we have to go backward. You have to start coming together. Young men don't have opportunities here, there are no jobs.


