Conrad Fisher-Explain briefly, the ICDBG. For example, 14, what is some of the work being done on these houses?

Lafe Haugen-We are replacing doors, making them handicap accessible, putting security doors in, redoing the bathrooms. It's the basics of what HUD requires. It is to make the homes safe and sanitary.

Tracy Robinson-We're running into high electrical bills. A lot of our houses are equipped with baseboard heating. We put a lot of money toward our elderly. Are there others ways to reduce the bills? I don't know if wood stoves fit in under the insurance. Has NCTHA looked at other ways?

Lafe Haugen-Some homes already have wood stoves or fireplaces. By changing the windows, it helps cut the heating costs down. We are always looking at different ways.

Conrad Fisher-According to our contract, they would only take out 200 pounds of pipe. They already took 500 pounds of it out. This is a hazard to the community. They have violated our Solid Waste Code. We want to make sure that IHS takes full responsibility for this.

Tracy Robinson-It always seems that BIA and IHS downright ignore us. Is there anything more we can do that has teeth to it? We need a deadline. What type of fence should be installed? What

exactly do we want? It should be 6 ft. high, chain link, a security fence. Upon the Presidents' signature, they should have 30 days to complete.

Brian Chestnut-There is an enforcement code included in there. I don't think IHS is used to getting enforcement orders from the Tribe.

Willie Rowland-Why did IHS choose to bury it on our ground?

Brian Chestnut-It was done by an independent contractor, illegally.

Christie Avery-It will be removed.

Ernest Littlemouth-Summer is coming, we need a fence up as soon as possible.

Tracy Robinson-Is there something we should file a TORTE claim on?

President Fisher-Something needs to be done.

Conrad Fisher-If there's some tribal resources we can use, it's something that important, we need to putting something out there today.


