### RESCIND FEE RATE MORATORIUM NCUC-ADAM SPANG

Dana Eaglefeathers-I thought we discussed that commercial was at least 30%.

Adam Spang-We will do a rate study.

Amanda Whiteshirt-I would like to see a sliding scale. Where is the standard rate? How much much money is for employees? There has been inadequate record keeping, and the water discharge. Those should already be in place. The Tribal Council shouldn't give up any authority over tribal programs.

Henry Speelman-This is just commercial rates at this time.

Lane Spottedelk-NCUC, to show they will be a viable business. We would like to have the best equipment.

Merlin Sioux-When was the last time you had an audit?

Cowboy Fisher-They said the last time was in 2006.

Merlin Sioux-It's really important. I asked about the census for funding. We need an accurate count.

Dana Eaglefeathers-We had a meeting in Billings, this was the easiest way to get more money. They're not going to touch the residential rates. We will work on getting an audit.

Cowboy Fisher-We want to become autonomous so we can raise the rate. We are going to have to raise the moratorium on residential.
