Roberta Harris-I have been working on areas of non-compliance. We have 120 days to address all these areas, we got an extension for another 120 days. We're looking to address some areas of need. We're looking at getting a full time consultant, we're looking at getting school based funding. We will look at funding to address topics like head lice, right in the office. There's a thing called coffee with the Council, I'd like to look at starting that soon. Our enrollment is at 125. I applied for a duration grant. We did receive approval for 255,000. It's a startup funding to address some increases, and deficiencies that we have.

Diane Spottedelk-Do you have culture and language?

Roberta-We do.

Merlin Sioux-On your background checks, are you getting those done?

Roberta Harris- Yes. They take about 4-6 weeks to get back.

Lane Spottedelk-I think there's potential to expand. If you can push to get that expanded to employees.

Roberta Harris-I would definitely be interested in that.

Debra Charette-You have one driver that I thought could take over the director of transportation.

Roberta Harris-With our enrollment, we have been discussing our structure.

Debra Charette-If your kids are in Headstart, send them to school. It's really important.

President Peña-We did meet with Bill Briggs, we talked about getting the classes and all the teachers certified.

Roberta Harris-We have one child that got chicken pox. We had issues with hand mouth disease too.

#### COMPLAINT FOR REMOVAL/GENE SMALL-DANA EAGLEFEATHERS

Gene Small-When I filed the complaint, my intention wasn't to remove Rennie. The number one reason for filing and why my complaint should be heard is that the land owner is not getting paid. The alottee is not getting paid. For personal reasons, personal interests, this has been ignored. I think those alottees should have been paid. You drug the alottee into the fight.

Tweety Littlebird-I want to come back to how the societies got involved. I can see it's personal right now. That land in Busby, the reason we got involved. In Busby, an elder was shot at. Our water got contaminated. Our land is important to us. We stepped in to support our cause. There is over \$100,000 that is owed to our people. Get some of us involved and help the situation. You had a revival in here in this very building to help each other. There is something going on out there and the societies. I can see this getting personal, this is not Crow, this is not Lodge Grass.

Henry Speelman-Your two minutes is up.

RD Bailey-Thank you for allowing me to say a couple words. It's a sad day, there is no integrity within this circle. From sitting on the outside, it's about friendships, favors and pat on the back. These complaints getting thrown out as they are, is ridiculous. It should be based off a legal basis. How your lawyer guides you. I just tried to get a personnel manual, I can't even get it. It doesn't make any sense. How are you going to alleviate this? It's embarrassing. Where's our leadership? I'm ashamed today, and it's not even being conducted in a professional way. Not just saying that 6 of us can kill a resolution. Settle something on a professional level. Adult to adult, reasoning.

President Peña-In the Constitution it's our job to decide on the land. That totally lies in the Councils hands.

Debra Charette-We overrode it and we asked that she advertise for a five member land committee.

Kenny Medicinebull-Talk about being professional. We need to respect our leaders. I'm supposed to have all respect to you. You're our leader, I apologized and shook her hand. I tried to sneak some popcorn, she turned away. This Land Authority, number one they said we can go onto any land and do our business. The code of federal regulations doesn't allow that. That's your land, they just can't come on there and do whatever they want. This Ordinance should have never been approved by BIA. You want any information from Land Authority, you have to talk to director. Whoever that Director was didn't do his job. Instead he wanted to extend the lease for another year. They have another director that works the same way.

Robert Simpson-You want to step up?

Kenny Medicinebull-I sat back there and listen to everybody. I'm an elder, I still have all my paints in the Sundance.

Stella Wallowing-Shouldn't Diane be listening instead of walking out

Tweety Littlebird-I want to apologize for hollering. We just didn't just put this together. There was the majority of the societies, we came to support the Land Authority. I asked in a good way not to give it back to the Bureau. We decided we want to work with the Council that can do something better. That is wrong to do that. What about the money that is owed to the Land owners? The Council is the board. You guys got mixed up in how you processed it. We are ready to bring that to the table if we have to. I have a lot of respect for you. The people need to know something, we have grandchildren. You sat there and talked about hiring practices. What's the Headstart doing over there that's not even a member? I don't think myself, the legal opinions, releasing Gene wasn't right. Did you read how he was terminated? You released him because lack of duty. This is personal, that is not the way to conduct business. It's not to get rid of you, it's how you're conducting things. There's a lot of them. Then start putting a cultural stance. You guys, it was an override, you took it back to the Bureau. Isn't she just supposed to sign and give it back? We asked, what is the process? What about this lady, we're talking about kids. Since I've been home, I've been living a prayerful life. If it means I get whipped, so be it. I'm going to stand up for my people, stand up for my children. Since he got down there, there's stuff that people can use. What about this grazing? We're ahead of you guys. How can the water at Stebbins Creek be contaminated. You guys he deserves to have a chance. He is not just a half breed, he is a member of the Elks. That's our only hope over there for our societies to survive. You guys are acting like Trump. You're going to pick a board, when you were supposed to advertise.

Dana Eaglefeathers-We can save our arguments if it goes to a hearing.

Stella Wallowing-Why is the BIA here? This is for the tribal members.

Branden Mikkanen-We received a call that there was a disturbance here.

Florene Whiteman-There was a disturbance here.

Stella Wallowing-As a landowner, where is our money? Why are you trying to get Gene out when the land owner hasn't been paid?

Tom LaFranier-I'm a land owner, I didn't get paid. Rennie said, it's all hearsay. Use both ears, listen to both sides.

President Peña-We both have rights, Gene has rights, and I have rights.

Stella Wallowing-Why should we have respect for Council when they don't have respect for us? Why do you need to make a decision? We want to approve it.

President Peña-I'm a land owner too. None of this has nothing to do about me not getting paid. I didn't have a say so in any of this.

Dana Eaglefethers-This is per the Constitution. It was actually the Sgt. At Arms duty to get this where it's at today. It's a process that needs to be done.
