J. David Roundstone-Gene is an Elk Society Member. He doesn't have a problem with it. If they don't finish the fence, we'll lose the funding. We said it's not going to happen overnight. We're looking at maybe next year. He also let us know that there's about 400 horses in that unit. He has a plan for that too. We don't want to jeopardize the funding, there's still planning that has to take place. We're hoping it will awaken some of our traditional values. It has potential to sustain itself if it's done right. We need to focus on responsibility and accountability. They are fit to eat, even though they're a little poor. We're at the tail end of our traditional era. We've lost a lot. This pandemic has a huge potential impact on our elderly. We're losing our language. I do know that we support the buffalo program.

#### Via Teleconference-Paul McKean/Lynn Caraveau/Hanna Wagner

Paul McKean-The last two days have actually been good. The good news is, the accounts are invested in bonds. We're holding quite a bit in money market funds. Our outlook is that there could be more. We do not recommend any major changes. There are not any major shifts. Mainly we're here to answer your questions.

Lane Spottedelk-Thank you for taking time to visit with us. The last time we talked, we talked about the government.

Paul McKean-They voted on a package that's 2 trillion dollars. They're trying to help stimulate the economy. They're trying to reduce the amount of damage that's going to occur. They're saying they want to give money to each American.

Debra Charette-With everything going on, will our Permanent Fund go down much?

Paul McKean-It's going down by a few million. The good thing is the allocation is determined by a percentage of the average for 3-4 years.

Debra Charette-Should we be doing something else to make sure out money is safe and secure?

Paul McKean-I would not recommend selling stocks right now. At times like this we definitely take a hit.

Brian Chestnut-The stock market has been horrible. Is the Northern Cheyenne Portfolio set up for cases like this?

Paul McKean-The portfolio is designed to provide protection like this.

Brian Chestnut-Looking at the memo, we're eight days later, are you still recommending that? The shift you're recommending is convert from fixed bonds, into stocks.

Paul McKean-Yes.
