NCTHA CARES ACT-LANE SPOTTEDELK

Lane Spottedelk-We're looking at additional appropriations for the CARES Act. Under the existing MOU, there's a proposal to increase the ceiling.

Rodney Trahan-We've had a number of things that came up that didn't fall under the original MOA. We've found that we're going to run on the \$200,000, we're doubling that. There's been discussion on the positions of Scott Small and John Grinsell. We went back and pulled the salary expenses. We projected from today until the end of the year for those salary expenses. The salaries did not include fringe and payroll taxes. We didn't budget hazard pay and we've run out as of this last payperiod.

Merlin Sioux-We love to help our tribal programs. We have Morning Star Propane, a tribal business. We have this tribal business and we were told you were using Amerigas.

Rodney Trahan-They don't have the tank size that we need.

Philip Beckman-I'm sure they can get it.

Debra Charette-Amerigas tortured our people.

Rodney Trahan-We have to get bids, we still have to get quotes.

Philip Beckman-The concern is the company, they're continuing to mistreat our people. I believe that they shouldn't be allowed on this reservation at all. It doesn't make sense to send money off our reservation, there's a resolution in place to use tribal businesses.

Rodney Trahan-The one thing is they don't have 500 gallon tanks. All I request is that he contact me as a professional.

Philip Beckman-We're getting employment numbers, and with the deadline coming up, Housing Authority has answered the call.

Merlin Sioux-We can help accommodate, we can get tanks and use CARES Act funding. We are going to support our own business.

Rodney Trahan-We are requesting that \$200 per month be utilized toward water, electricity, or propane per unit. When a low rent tenants electricity gets shut off, we get a lot of burned out stoves and sockets this time of year. In a lot of respects, we have a vested interest.

Eva Foote-What about wood stoves?

Rodney Trahan-We're trying to phase those out because they are a safety hazard. Insurance won't over it.

COVID 19 LEAVE POLICY-DEBRA CHARETTE

William Walksalong-It feels different with no Vice President. It's very rare that someone passes away during their term. Every morning he would bring cedar to my office.

William Walksalong-This all falls back on COVID 19. There's no emergency leave in our current policy. The President issued a memorandum establishing emergency leave. People that were high risk, exposed, sick, children in need of care at home, they were given wide open authority to stay home. Many of them stayed home. If people deplete their leave, they have to apply for FMLA. You have to apply for this emergency paid leave. I have confidence in attorney Naas' draft. It's up to the Tribal Council.

Denise Swank-The draft pretty much covers everything. The Federal mandate and the State.

William Walksalong-There is a stack of memorandums that went out. For this particular issue, it's having people come back to work.

Lane Spottedelk-Does this proposed legislation address long term systematic issues?

Debra Charette-It's effective November 9th.

Denise Swank-This policy has a review date of December.

It has been reported that every reservation except for our has satellite clinics. Our attorney put the final touches on this. In the past IHS governing body meetings, they make over 10 million dollars in revenue from third party billing.

Eva Foote-Does that also go with dialysis?

Eugene Littlecoyote-No, but it can be worked in. The planning should take into account on a local dialysis.
