They want everyone to come down when they have those events. The director wants to meet with the Chief of Police, they are the lowest paid board. They want to request some walk in showers for some of the

elders in the districts. In the elderly complex, Ernie Robinson is in charge of the building. They have a hard time getting a hold of him sometimes. They requested that he move his office into the complex building.

Eva Foote-Their concern about Ernie moving over, would that be his office?

Waylon Rogers-They respond, they don't know what room to go to. They can't get a hold of anyone to get the key.

Eva Foote-Roger Killsnight, Sr., is he retired or does he still have an office there?

Waylon Rogers-He still has an office there.

Lane Spottedelk-Elderly Liaisons and Housing Liaisons should get together to meet on these issues.

DISTRICT UPDATE

Nellie Ann Whitedshield & Amanda Whiteshirt-Lame Deer District

Philip Beckman-On Veterans Day in Busby District we're having a meal, and a couple of us have thrown in on it.

Nellie Ann Whiteshield-The judges, the background checks go to the HR, that position is just an appointment. The charity money that you guys get, take a percentage out of it and give it to the districts. There is a lot of concerns out there in the community. There are concerns about the children. The next meeting I'm going to set up will be on the 16th. I'm working on getting our children back. You guys are invited. So far, I have never seen anything on the plan you guys have passed to bring our children back. All you have to do is pick up a phone. When I come down here, I look at the billboard, travel, travel. I can't even get through to the judges down there. I would really appreciate it and when I do a packet, for a special. Our kids are being discriminated by teachers, that are calling out and ridiculing our children. Lastly, I appreciate Dana's help. We have a lot of concerns for our homeless people.

Dana Eaglefeathers-There's an electrician and plumber coming. Lame Deer District can create a plan.

Amanda Whiteshirt-We plan to open up the homeless shelter very soon.

Nellie Ann Whiteshield-The reason why I started pushing it, there's a few people that were frozen out there. The ones that are helping me are Dana, Lane, and Waylon. This jail down here, find out what's wrong with it, bring our people back. These inmates too, they are going to a federal private facility.

Amanda Whiteshirt-If it's a private prison every prisoner has a dollar on his back.

Nellie Ann Whiteshield- These are district concerns.

Henry Speelman-Tester is coming in to help open this jail up.

Amanda Whiteshirt-Every member on this reservation, have a right to talk to this council about their concerns. Everybody should have a voice here. We are individual members and we have every right to voice our concerns. Dog Ordinance, cops don't seem to be enforcing it. If a dog is mean, vicious, it needs to be killed if it attacks anyone. We stopped, getting his bike for him he was standing on the corner crying. Cops were called, and they didn't kill the dog. Utilities, it's my understanding that every tribal member is an owner of this reservation. Our water belongs to all of us. When it first started Elders were excluded, elders have to pay again.

Henry Speelman-You're not paying for the water, you're paying for the service.

Amanda Whiteshirt-We need to be able to drink our water.

Nellie Ann Whiteshield-Right now, we put a hold on our district to see where we're at. When we start using our grandkids over and over. We can't repeat, it's limited. I'm going to help this family again, that you guys sent up to my house. If I do it for one, I do it for all.

Dana Eaglefeathers-When your allocation comes in, maybe bring a list of who you help.

Nellie Ann Whiteshield-We're duplicating services, we're trying to stop it.

Eva Foote-Ashland District had a meeting on October 30th. The budget passed. They do have some money for renovations for our community hall. Joey Littlebird is getting quotes to fix the heater. Because of where the water line is for the bathrooms, they have to tear out the basketball court. If the tribe could help out with some of those costs.

Lane Spottedelk-If board of health, could do some youth activities or outreach. Their funds allow them to do remodeling.

Eva Foote-Fonda Redfox, said that she could also get some money out of the coal board.

Vice President Russell-What's the ones across by the river by the school.

Eva Foote-There's no walkway for our children over there. Everything is at St. Labre, boys & girls club, swimming pool. People don't have transportation to get their kids over there. Muddy, Birney, and Ashland.

Ernest Littlemouth-We had a meeting, our Chairman is Lisa Limpy Just, and Vice Chairman is Doris Medicinebull. The meeting went good, what she was saying about giving out district money. They decided to help out one person per household and switch out the next one.

Their homeless shelter, there are people staying there. It's open, established, it doesn't have a bathroom. I know he has more than 8 people in there, including children.

Ryhal Rowland-We passed our budget-\$50 for youth, \$60 for young adults, can only get assistance every three months. We did a pumpkin decorating, we had a few games, Ray Limpy

rold a story in Cheyenne and taught the kids how to say pumpkin. There was 80 people that attended. We have a meeting on Wednesday.

Philip Beckman-They go to administration.

Waylon Rogers-This will be given to administration?

Amanda Whiteshirt-Give them a chance to look at for a day or two.

Waylon Rogers-I gave them the names a couple of months ago. She wanted a list of my recommendations, she ultimately has the final say.

Dana Eaglefeathers-So the letters of interest closed?

The window of flowering is going to be too short.

Amanda Whiteshirt-You're going to make an agreement for 10 years, what are we agreeing on? Are we leasing the land, and they take the product? Do we own part of the product?

Waylon Rogers-this is just a letter of intent. We are not negotiating at this time.

Philip Beckman-You're talking about CBD.

Waylon Rogers-CBD is a different animal than hemp fiber.
