### INVITATION TO BID LAME DEER LAGOON RENOVATION, PHASE 1 IHS/NC TRIBE

Sealed bids for the construction of Lame Deer Lagoon Renovation, Phase 1 will be received by the Procurement Office of Northern Cheyenne Tribe until 11:00 am September 15, 2017.

The project consists of generally of renovation of an existing wastewater lagoon, including the following:

- Installation of a new effluent discharge and transfer structure.
- Installation of a blower system and enclosure.
- Installation of underground air pipe to manifold boxes for treatment equipment.
- Installation of anchor posts to support floating lagoon baffles.
