The Northern Cheyenne Tribe is now accepting sealed bids for Equipment Rental Services located within the exterior boundaries of the Northern Cheyenne Reservation located in Montana.

Contractor shall furnish all necessary personnel, equipment and materials needed to complete the work as requested by the Tribal Forestry Program. This bid should include the following:

SCOPE OF WORK:

1. Contractor must have all the equipment needed to perform the project of rehab old logging deck areas that were burned leaving an area that can't grow grass, only weeds.
2. Contractor shall perform the tasks listed in the contract as required and shall work without supervisory coverage with Tribal Forestry inspectors doing daily coverage of the work.
3. The contractor shall furnish all necessary personnel, equipment, and materials except as otherwise specified as may be needed for performance.
4. The project will consist of rehab of each old logging deck locations as assigned, dozer out all the unburned slash/ash, rip the ground no less than three (3) feet deep, then grass seed the burned spot area.

Emailed or faxed proposals will not be allowed and late proposals will not be considered. REQUIRED DOCUMENTS INCLUDE THE FOLLOWING:

INDIAN PREFERENCE. The owner will factor Indian preference into the bid analysis process however it will in no case be the sole deciding factor in awarding work. Evidence of eligibility for Indian preference must be submitted with the proposal. Responsible bids will be accepted from Non-Indian owned contractors. In evaluation of the bids, the Tribe may, within funding limitations, give preference in the amount of 5% above the lowest total bid, to qualified Indian owned firms.

TERO. Each contractor is required to be certified by the Tribal Employment Rights Office (TERO) prior to submitting a bid in accordance with the Northern Cheyenne TERO Ordinance. The contractor is required to comply with the requirements of the Northern Cheyenne Tribal Employment Rights Office.
