Ben Lonebear-I'm pleased to hear the history of the personnel manual, it's a lot of cost and time systems management must be adopted to operate federal funding it was violating the CFR.

Ann Knowshisgun-I don't agree with rescinding the resolution.

President Killsback-The new manual clarifies, up the leave earning, volunteers protect our fire fighters had to upgrade sexual harassment because of the law, changed the drug policies and added the medical marijuana I don't know why this is an issue, Denise has a list of issues for the ready for the meeting.

Debbie Charette-Do we go with your suggestion by putting William in charge until they have a meeting?
