COUNCILWOMAN LONEBEAR: 108. We're requesting to sole source, I talked to Steve, because he is a tribal member and just the meaning of the mountain to him. He did a draft. This is what it'll be though. The \$75,000. His draft budget. This is a resolution of the Northern Cheyenne Tribal Council approving the sole sourcing of a construction contract between the Northern Cheyenne Tribe and Red Shale Construction for the Bear Butte House. That is my motion.

COUNCILWOMAN LONEBEAR: I do want to mention also, for the record. The intent is not to make the properties over there into biker bar properties. We will be bringing something forward for the campground, as well. But it's to provide our people, first of all, a sacred place to go with water and toilets and everything else and to provide our people that go down there for ceremony places to cook and fill their waters tanks and a place to stay and for youth camps.

VICE-PRESIDENT LITTLEMOUTH, SR.: It would be good if you could get different cabin out there.

COUNCILWOMAN FISHER: Maybe we could look at something for that campground area.

COUNCILWOMAN CHARETTE: I think EPD is going down to do assessments on some of the older ones standing there and then they'll come back with their recommendations.

VICE-PRESIDENT LITTLEMOUTH, SR.: They're ready to fall down. Some of them.

COUNCILWOMAN LONEBEAR: We have a demo plan for the stuff that is unsafe.

VICE-PRESIDENT LITTLEMOUTH, SR.: Lafe's been asking if he could build some smaller cabins.

COUNCILWOMAN CHARETTE: We're working on it.

COUNCILMAN DAVIE: Since the Rosebud Sioux Lodge burned down, Tribes really don't have a place out there that has electricity and shower house and stuff like that. I remember when I was a kid, that was probably in 5th grade, I went over there with Eugene and Project Morningstar. Went over to Bear Butte. Stayed in a tipi for a night and then came back home the next day. I mean, there's nothing out there like that for even the youth, the kids, for the elders. I know there's elder, when we were out there doing the clean-up, a couple of elders, ladies, came out that were going out to pray and tie clothes to the trees. They stopped and said, wow, we're glad that somebody out here and they're actually. I stayed out there for a couple of days, 2-3 days mowing the grass as much as I could. Trying to do what we could. We bought a piece of equipment for Kaden to do what we were doing so he could keep up on it. We want to try to make it a place for people to go and do their ceremony, do what they went to Bear Butte to do. You know, safe environment. Clean environment. And structures that aren't ready to fall to the ground. It's priority. It's been priority for council for about a year now. When we went up there to do that cleaning it was evident that it needed some attention. It's been in the center of our minds. I won't say it's been in the for front. It's been in the center of our minds for a while now. We need to do something for that mountain and take better care of it. We need to put the ownness to ourselves. If I'm gonna put myself like that, I'm gonna say I'm just as guilty as anybody else because I could have went out there at any time and took care of it. We need to do it now though so it need to be priority. I hear you Ernest. We got a plan. Trying to get everybody involved so that everybody can be a part of it.

ITEM #3 - BUDGETS

COUNCILWOMAN CHARETTE: Before we do this resolution. This is the one that corrects what was brought up in the removal hearing about the \$500,000 that was missing. It was a typo. The 5 was a mistake that was omitted off of the typing of the resolution. This resolution was brought up during the removal hearing. This is to correct it. The President signed the original budget on January 31st. So, when the statement was made that she didn't know where this money was, that's untrue and it insinuated that there was wrongdoing of \$500,000 missing. So, to let our viewing audience know the budget and the amount was on the original budget and this is just to correct one number that was left off of the original resolution. So, I make a motion for resolution of the Northern Cheyenne Tribal Council authorizing the modification and or adoption of certain budgets. This will replace the original resolution of DOI-049 (2024) and that one will be rescinded in its entirety and that one will be put on. Therefore, be it resolved that the Northern Cheyenne Tribal Council hereby authorizes the following budgets to be enacted or modified and approves the contemplated expenditures contained in the presented budgets, subject to the listed conditions, restrictions or constraints. Program budgets for fiscal year 2024. Fund 830A, 830G, 830I, 830J, 830L, 830M where the correction was made where the 5 was omitted, 830N, 830P. That is my motion.
